Credentials, Del and Clara Walker then gave their report. Thirty-one credentialed persons representing twenty-one clubs were present. Clara asked that seven additional persons be voted in to make the club representation twenty-four. Larry Ferguson moved that the assembly accept the additional seven as voting representatives of their respective clubs. Paul Heesacker seconded. A unanimous show of paddles gave a yes vote to their acceptance. Clara then reminded clubs to turn in the names of their Directors and Delegates prior to the meeting and to send the signed credentials with the representatives. (Clara later informed the Secretary a credentialed late arrival had joined the assemblage making the total representation thirty-nine representing twenty-five clubs.)

Pastor Evan Day led the Invocation as an official start of the business at hand.

Junior Chairperson, Audrey Vogelpohl presented the Junior Achievement Awards. Each child receives a certificate and a monetary award.

Total dollar amount for awards was \$375 with recipients awarded from \$25-\$100 range. One of the previous Junior recipients stated she bought an all-purpose grinding machine with the award money.

NFMS Representative for the AFMS Endowment fund, Judi Allison, pointed out the benefits of supporting the Fund. The interest if sued for AFMS special projects such as Junior Rockhound Badges, Judges training and digitizing media, to name a few. Besides, you might win a prize. With that she offered tickets for sale. (Thanks to all who bought tickets and good luck with the drawing to take place at Ventura, California during the 2017 AFMS Show.)

President, Jim Bosley let the group know that Joe Slouber had brought in tickets for a dollar off admission at the World Museum of Mining in Butte. Thanks, Joe.

Jim also stated it was a fun year. We need to keep in mind the challenges and worries with the Federal Agencies. Individuals clubs can get information quickly now via the internet. We need to take heed of the new bills relevant to sage grouse habitat or by default we could have land closed to public use for twenty years.

(Following is Jim's annual report.)

I would like to thank you for the opportunity to be your president in 2016-2017. I appreciate the help that Executive Board Members, Committee Chairs and Federations Directors have provided throughout the year. Their hard work has helped make my year run smooth. I would like to thank the Bitterroot Gem and Mineral Society for hosting the 2017 NFMS Show.

I would like to thank our Executive Secretary; Judi Allison who knows what has to been done and makes sure in is done on time. I would like to thank our Treasurer; Lyle Voglephol for his help in understanding the history and finances of the NFMS. I would like to thank our 1st Vice President and 2nd Vice President; Keith Fackrell and Ronna Watkins, respectively, for the help they have given during the year. I know they will provide great leadership in the future.

Other members that have taken on additional responsibilities for the NFMS are Doug True for 2017 Scholarships and Linda Barlow has taken the Historian Chair.

The challenges that face the NFMS [including local societies] are access to public lands for rock collecting and attracting and retaining new members, and communicating with the younger generation.

Access to public lands for rock collecting will require all the societies that make up the NFMS to monitor the Federal Agencies land use plans to insure we are included in the decisions made. We need to develop working relationships with the Federal Agencies and national and local political leaders in our states. We need to educate these groups on our needs and practices to insure access to rocks and minerals on our public lands. We need to support ALAA and keep them informed of issues in the Northwest.

Membership in the NFMS appears to be down for 2016 and 2017 by a few hundred members. Membership is a moving target and it swells with new members joining at our gem and mineral shows and drops off after the summer. The challenge is how to make the society relevant to families and younger people using the communication media they favor. This means that old dogs have to learn new tricks.

We need help with the following; 1) a new Endowment Chair and 2) a society to host the 2019 NFMS Show. Thanks you for a great year.

Secretary, Judi Allison encouraged all present to borrow their clubs' Federation Directory and peruse its contents if they have not already done so. She also encouraged all to make use of email. She is very open to input and questions and will answer any correspondence sent her way. (**Below is her report.**) As always, our annual meeting sneaks up on me more rapidly than I am necessarily ready for. Perhaps if I didn't have my hands in so many pies, it might come upon me in a more gradual manner. At any rate, I am looking forward to a wonderful show in Hamilton, Montana and a productive, well attended meeting. Again, if you are the Director, Delegate or other representative for you club and you feel you are not receiving information, please let me know. I try to include additional names on my email lists so every society will receive what I send out. If you are receiving my emails which contain information about the Federation, the agenda for the meeting or whatever else, I would love to have you shoot back an "I got it" so I know you receive the information.

Since many who have taken the position of Director or Delegate or may be 'standing in' might not have had access to their club's Federation Directory, I decided to list the information given under:

Send to the NFMS Executive Secretary by the 1st of February, prior to the Annual Meeting, all proposed amendments to the NFMS By-Laws and proposed resolutions from his/her society.

Send names and addresses of the newly elected Officers of His/her Society, and the name and address of the Director who will act for his/her Society for the coming year.

Attend and give a report of the Mid-Year Meeting in his//her area. {There is now only one Mid-Year meeting if the Executive Board deems necessary-Article XIII Part C of the By-Laws discusses this.}

Pick up the NFMS Directories and Show Packets and/or other NFMS Supplies as may have been ordered by the Member Society, at the Mid-Year Meetings. {Or Annual}

Present to his/her Society for their instruction, all business to be considered or transacted at the Annual Meeting.

Give a report to his/her Society on the Annual Meeting and the Minutes for the Annual Meeting. Perform any and all such other duties as may be necessary between his/her Society and the Executive Board. (Just a reminder: Each society receives at least one Directory. In addition to listing the entire membership, Articles of Incorporation, By-Laws, Operating Procedures and a complete list of the NFMS Program Library holdings can be found there. If you haven't perused it, why not ask to borrow it and enlighten yourself a bit more about our Federation?)

NFMS Treasurer-Lyle Vogelpohl Lyle reported that, sadly, the Tualatin Valley Rock and Gem Club voted to drop out of the Federation this year. That helped cause a total decline of 127 members. The Club's main reason for the pull-out was stated as the cost of dues being too expensive.

The Financials for the Junior Achievement Fund are included under Appendix I. Sandy Hansen of the Magic Valley Gem Club works for Wal-Mart. Since her club is a 501C3 (nonprofit) organization, for every twenty-five hours she volunteers in her club she has set it up for Wal-Mart to donate \$250 to the Federation. Thus far \$1250 has been donated because of her volunteerism. Sandy has requested that the money be used for Junior Programs. If you have ideas or suggestions for its use, please let Lyle or Audrey know. And a big Thanks to Sandy Hansen for setting that up. You might consider the idea also. **See Appendix I**

Budget – Keith Fackrell, 1st Vice President stated the proposed budget is in the packet. It was noted that the assembly needs to vote to approve the proposal. Larry Ferguson moved and Doug True seconded to accept the proposal as written. Motion carried.

Endowment Fund – (Chair Position Open) Jim Brain, Financial Advisor See Appendix IV

Lyle Vogelpohl reported that the fund is now being managed by Charles Schwab. At the annual meeting in Albany, Oregon last year a vote against opening up the fund to public requests passed 44-0. The fund was originally established so there would not be a need to raise dues. With that in mind perhaps funds could be used from the endowment unrestricted monies to offset cost.

As Director, Audrey Vogelpohl read the following proposal:

In keeping with the purpose of the Endowment Fund to provide funds to enhance programs of the NFMS And following the guidelines that these funds shall be used for the general benefit of the NFMS membership And at the direction of the delegates and directors in attendance at this annual meeting

It be moved that the 2017-18 NFMS dues of each adult member be offset by @1.00 from the Endowment Fund. Audrey Vogelpohl, Federation Director

The motion was seconded by Clara Walker. The motion was then opened up for discussion. Doug True asked if this could be voted on and be done with or would it need to be held over for the future. It can be approved at the meetings as it is an Operating Procedure. Jim Brain commented that it is a one year commitment. We do not yet have a long track record with Charles Schwab. Michael Blanton asked if it could be sustainable. Lyle suggested that this year is a try out as the result of an approval will take approximately \$5600 from the fund. Larry Ferguson asked about tax status. There is no problem, as the amount is too small to cause an issue. A vote was then called for. Motion passed with one descent. *Individual adult member dues will be offset by one dollar for the 2017-18 year*.

NFMS Annual Meeting Minutes – Friday, May 19, 2017

It was again pointed out that we need a new Chairperson for the Endowment Fund Committee. Edna Nelson has resigned. If you are interested or know of someone, please let our current President, Jim or President Elect, Keith know.

Jim Brain suggested there might also be other ways of using the endowment fund to further the purpose of the Federation. Lyle talked about the 50-50 split for the shows. Perhaps that could be a change. Doug True stated that in recent years it has been negotiable. He recommended the Federation get 20%. Jim suggested the possibility of traveling exhibits to go to shows. Larry Ferguson pointed out that the host needs to have information about negotiation. He asked if there was negotiation on the silent auction. He also stated the "show book" needs to be redone. Jim said it is an opportunity for us to help shape the future. We need to work on getting out better information about the shows and possible negotiations and requirements. There was a discussion about the existence of a manual for putting on a show. Some knew of the existence, others had no idea. At any rate, it needs to be refined and updated. Judi will work on blending what exists to create a step by step "how-to" manual for putting on a show. Although some were quite sure one might still be in existence, Michael Blanton felt it was a "mythical Manual". We will work to correct that issue. Evan Day pointed out the operating Procedures state that 50% of the net profits go to the Federation. There can be some basic negotiations. When Ogden hosted the show they wrote that they would split 50-50 any net profits over \$3000. That amount was chosen, as that was their usual take at a regular show, and by creating such a clause in their proposal, it assured they would profit at least equally with their regular years. Lyle encouraged those who might be interested in hosting a show to submit a written proposal for negotiation.

Field Trip - Doug True spoke about the National trip held in Prineville last year. Over 100 people attended. This year because of the 120-170% snow pack, many sites are essentially out of reach. There will be a usual annual trip to the Blue Forest May 25-28 that will serve as a Federation trip.

Historian – **Linda Barlow** states she has now collected "stuff" from Tendoy, Idaho. She will be updating the museum list which will include places that contribute to our hobby in some way. She plans to digitize information back to 1939 so it can be stored in a more compact manner. She will continue to write articles for the Newsletter. Ed Moser informed the collective that the Glen Evans Museum in Caldwell, Idaho is open Tuesday – Saturday 1-5. It houses a nice collection of rockhound interest. That is the type museum Linda is looking to add to the list. (Following is her annual report)

2017 HISTORIAN REPORT Due to severe Idaho winter and spring storms, I have been prevented from receiving the NFMS Historical Files. This has delayed (1) digitalizing the Historical Files, (2) creating or updating our regional museum listing, and (3) a display of Historical items at 2017 NFMS Convention. Budget request for this year is for transferring of Historical files to my garage preventing storage charge and enabling my easy access for the above being achieved by 2018 NFMS Annual Meeting.

This year, I have started writing a monthly Historian article in the NFMS Newsletter.

I am asking to be contacted for any memorabilia from the 2016 NFMS Annual Show that I can add to the Historical Files including show pins, case favors, Banquet favors & programs, bulletin editors' breakfast program, photographs, & any other memorabilia that NFMS members may have that they want to donate to the Historical Files.

Juniors - **Audrey Vogelpohl** reported that last year the number of clubs with Juniors increased from 39 to 47. This was an increase from 551 juniors to 591. Rockhounding is a family activity, so juniors are very important to the hobby. Audrey will hold a Cracker Barrel session Sunday at 10:00 am. Audrey also pointed out that she is stepping down from the position at the end of this year. Thank you, Audrey, for your service.

Newsletter Editor - Beth Heesacker stated that her mission this year will be to encourage all clubs to receive their Newsletters electronically. You get it earlier than the hard copy and it is in color. Judi Allison said their club added a statement on their membership application form that says "unless otherwise requested, all publications will be send electronically."

Beth reminded everyone that any awards given and lists of winners should be given to her for publication in the Newsletter. The deadline for the next issue is June 15th. (Below is Beth's written report)

I am sure everyone read the introduction of the 2nd VP nominee Kenneth Zhan in the February 2017 issue of the NFMS Newsletter. Once again, here is Kenneth Zhan's biography.

Kenneth Zahn, Candidate for NFMS 2nd VP.

• I began field collecting while pursuing several degrees in education and chemistry at the University of Arizona, 1954 - 1960, and continued to collect during my follow-on Army and private-life careers -- and after full retirement (2010). A member of 11 different clubs in 5 different AFMS Regions since 1972, I have most often served as field trip leader or program chairperson, rather than as an elected officer, primarily because of the Army practice of moving officers from assignment to assignment every few years. Since partially retiring in 2004, I have taken an active role in the local Bozeman, MT club, serving as program chair (since 2009), President, Executive Board member, Trustee of a valuable club-owned historical collection, field trip leader, Board member of the Montana Council, Club bylaws drafter, lecturer/presenter at area schools, fund-raising auctioneer, Club coordinator for its mining claims, commenter on proposed federal regulations and draft NEPA documents related to recreation on (and access to) national forest and BLM lands, and work on many other committees and show-related task groups that support club activities. I have assisted in organizing the annual "Montana Crystal Collectors" meeting by arranging speakers, giving presentations, and conducting fund-raising auctions. In 2014-2015, I organized gathering (on loan) the best samples of club-member-collected Montana minerals, purchased insurance, then transported and displayed the large collection at the annual Tucson Gem and Mineral Club show in February, 2015.

• Articles I have written on reviewing and commenting on federal-project draft NEPA documents and on club growth have appeared in past NFMS newsletters, and an article on the uniquely gemmy serpentine mineral Williamsite I've collected from the Maryland/Pennsylvania state line is posted on MINDAT/GEMDAT and has appeared in club newsletters, such as that of the Mineralogical Society of the District of Columbia (Dec. 2013).

• With great volunteer support, membership in our Bozeman club has increased from approximately 37 in 2007 to 200 as of mid-January 2017. The club has also recently opened a lapidary clubhouse, and placed a large display of Montana minerals at the Bozeman/Yellowstone International Airport. Our fund-raising auctions, raffles, and show profits have enabled us to be financially stable. I hope to share the many "Lessons-Learned" from my experiences (both in the Bozeman club and others of which I've been a member) with the wider NFMS family.

• My home library collection is approximately 8,000 - 10,000 books/journals, approximately 1/3 of which are related to mineralogy, geology, "gold-rush" history, mining, lapidary, field collecting, and other earth science and general science topics; I have a large collection of minerals in home display cases as well. These

also speak to my passion for this hobby. My current more-technical interests are on the pegmatites of the Boulder Batholith, and the fate of proposed federal agency regulations that threaten the collecting and National Forest/BLM-access aspects of our hobby. I look forward to meeting as many of you as possible within our NFMS Region over the next several years.

Video/slide Librarian Report The library only received one new video this year from the AFMS Program Competition. *Micromounts H-Z* by Michael Shaw. It is formatted to be presented via computer.

I would like to encourage each member and society to enter the AFMS Program competition. The purpose of this Competition is to recognize and reward authors of presentations about the Earth Sciences and to make winning programs available to affiliated Clubs across the country.

There are four classes of entry: <u>Educational</u> - about geology, minerals, gems, fossils, etc.; <u>Field Collecting</u> - showing site(s), specimens, with some geology, collecting methods and other aspects of interest.; <u>"How To Do It"</u> - techniques/equipment for fossil prep., jewelry, metal work, carving, faceting, other lapidary, etc.; and <u>"Just for Juniors"</u> - any of the above for/by Youngsters.

Program length for adult programs: 30- 40 minutes is optimum. Juniors is a 20 minutes suggested maximum Awards are \$200 cash prizes for the highest scoring program (for 95+ points), \$100 if score is 94 - 90 points, in Classes 1 - 4.

Stamps – Lyle pointed out that the old method of sending stamps to a dealer would result in \$200-250 a year. Now Chuck Sonner sells them on Ebay. For this fiscal year to date there is approximately a \$500 profit. Since the Operating Procedures state that such monies collected be used for cancer research, or other charitable use, Audrey Vogelpohl had an idea she presented to Chuck. He was in agreement as long as she brought it before the assembly for a vote. Audrey is aware of a 501c3 group in Seattle working on "Knitted Knockers" promoted by <u>www.knittedknockers.org</u>. which provides information on making knitted breast pads that are used in regular bras by mastectomy patients. They are given to patients free of charge. The yarn and fiberfill are of a special type and both are costly. Her proposal was to use the stamp profits to purchase the yarn and fiberfill. (Paul Heesacker is a quilter and is also donating extra of his polyester fiberfill.) Ken Zahn created a motion to accept the recommendation for use of the stamp funds to defray the cost of yarn and filling. Joe Slouber seconded. Michael Blanton asked if the group had approval of the 501c3 designation. The answer was yes. Audrey said one can check the website: knittedknockers.org. A vote was called for and the motion passed. The consensus was that stamp money can be used to purchase supplies for this worthy cause.

Ways & Means - Janice Van Cura (No report)

Webmaster - Brad Larson reported that these are things that happened in the last year. We have moved from the amfed.org/nfms to NorthwestFederation.org. This is so we don't rely on the AFAMFED for our site. We can now control what we want and don't want as far as features. The site was created around the 20th of June 2016. We have seen a significant increase in persons connecting to our new site. 70.2% are new to our site and 29.8% are returning persons to our site. We have had 7,656 visitors since June 20th 2016. (Brad further passed on the information given here to be added to the minutes.)

Countries that have visited our site: 91.5% from USA, 2% UK, 1.74% Russia, and visits from Canada, Italy, Brazil, Nigeria, Austria and India.

The top ten cities in the US that have visited our site are Portland, Seattle, Spokane, Salem, Boise, Missoula, Eugene, Corvallis and San Francisco. Top ten states with total connections: Washington, Oregon, California, Montana, Idaho, Utah, Texas, Arizona, Colorado, and North Carolina. Top five browsers used: Chrome 45%, Safari 21%, Firefox 12%, Internet Explorer 12%, and Microsoft Edge 5.5%. Type of systems and percentages: Desktop 61%, Mobile Phone 27% and Tablets 11.5%.

Some discussion ensued about difficulty in finding things on the site. Folks were trying to find the website contest and felt there was not a contact listed. Ken Zahn pointed out that all the names of the Committees and Chairpersons were listed in the directory along with their phone numbers. Try calling if you get no answer via email.

Website Competition - Cheri George (Cheri was unable to attend this year, but requested that we encourage clubs to enter the contest for next year.)

We had two entries in the Website Contest this year, very poor showing for such a prolific Federation. I would ask you to seriously work on your websites this year and consider entering them next year. If you need help, just ask me. I am at your beck and call as the NFMS Website Contest Chairman.

AlAA –**Lauran Williams** pointed out that the organization is the legislative arm of the Federation. Because it is a lobbying group, it is not tax deductible. Clubs and individuals both need to join. Go to public meetings and get on notification lists. By the time information gets to the general public it is too late.

2018 NFMS Show-Yakima, WA. Ronna Watkins stated there were packets for folks to pick up. She discussed the geological structure of the area.
