#### **MINUTES**

The meeting started at 3:34PM. **President, Larry Hulstrom** welcomed attendees and asked for those who could to please stand for the **Pledge of Allegiance**.

He then introduced the **Executive Officers**: Darrell Coyle,  $1^{st}$  Vice President, Treasurer, Linda Harvey; Secretary, Judi Allison; and  $2^{nd}$  Vice President Jennifer Haley, stating that Jennifer was in Scotland enjoying a pre-covid planned family reunion.

First Vice President, Darrell Coyle, named the Past Presidents present: Ronna Watkins, Hidemi Kira, Fritz Mack and Judi Allison. After introductions, **Ronna Watkins** offered a prayer for our fellowship and the success of our meeting. Larry then called for a moment of silence for those lost during the year and asked for members to add to his list for presentation at the annual AFMS Meeting in New Orleans on October 14<sup>th</sup>.

#### **OLD BUSINESS**

**Parliamentarian:** Since **Evan Day** was unable to attend because of a Covid exposure (his latest report was that he was doing well and symptom free), Larry stated that if there were any issues that could not be solved, the matter would be tabled. Chairpersons were then called on to present their reports in order by stating they were in the packet or by adding information.

(If additional information is not offered in the minutes, the report either stood as written or there was no report. Reports and addendums follow the minutes.)

Secretary, Judi, added: let the executive board know if there are ways we can be more visible and helpful.

Bulletin Aids/Website Contest Chair, Kat, spoke of the lack of submissions this year. She stated there are a variety of articles, as well as poems and drawings that can be entered. Darrell Coyle mentioned the possibility of including Facebook as a medium for the contest, since social media seems the way to go. Larry added there are other areas. Kat mentioned Event Brite and Instagram. The date for submissions for the 2022 website contest will be due mid-March. There was a discussion of where to find the criteria for entering the contests. Kat stated it was on the AFMS Website. It is very difficult to find. Judi will work to move the information on to the NFMS Site for easier access. Ronna reminded members that they need to submit stuff-cartoons, scientific articles, poems, etc. If the submission is only on line, it can be copied for the contest. Encourage, encourage. You can submit for someone

else. Judi stated the contests are for your own improvement. You can learn from the judges' comments and improve your work.

Mike Rose asked when we were going to vote in the directors. Larry explained it was pointed out that we get our old and new business mixed up, so we are trying to follow an order. The reports are old business. When we reach the new business section, the first order of business will be to do that.

**Endowment Financial Manager, Jim**, stated things were in the packet and added that things are worse now than a month ago when the report was created.

Our New **Historian**, **Robert**, said he was interested because his father was in it (the Federation) and he is glad to be here. Mike Rose then had a question for the Historian. Bev Bachman, former Newsletter Editor passed on a number of albums of pictures. He wondered if the Federation would have any use for them. It was decided that they could be surveyed by some that had been in the Federation for a time in order to decide if there was any historical value.

Juniors Chair, Gayle, urged folks to encourage their Juniors to submit for the Junior Achievement Award. As Nominations Chair, Larry introduced 2<sup>nd</sup> Vice President Nominee, Lora Hall. Her biography can be found under the reports.

Walt, Camp Hancock Chair, stated that the information was in the packet. We can pay our bills this year, but we may need help for a down payment for next year. It was suggested perhaps the fee would need to be adjusted. Cherice Ash asked if the retreat could be moved forward, since it fell right at the beginning of the schoolyear. Walt explained it was the only time available because it is a free week, as the employees are on vacation at that time. The idea of pursuing a different location appeared out of the question, since OMSI now owns the equipment and we use it.

Susie, PLAC Chair, stated she has attended sixteen meetings since the midyear NFMS meeting. These have included BLM meetings in Idaho, Oregon and Washington. Plan management needs input. If your favorite rockhound places are not mentioned, they may go into the land management and be closed. We need to make our voices heard. Rockhounds do well with the code of ethics, while others sometimes run amok. More Revisory Council Committees are being set up in each state, but people are passing up the opportunity out of mistrust. The committees need people. October 20-21 in John Day will be her first meeting as a Revisory Council Committee member. There are sixteen places being earmarked for closure. The BLM can trade with conservancy people and they can close off the lands. Vicki Johnson asked if we can contact those in charge to let our voices be heard. Robert Dalton mentioned Hampton Butte as an example dealing with closures. Susie stated she will try to reach out with social media such as Facebook and Instagram.

Laurie, Rockhound of the Year, Judi let those present know that Laurie was unable to attend because her husband recently had surgery. She urged people to choose an "Unsung Hero" and submit the name for honor. Josh, Rules and Awards, stated, "We need a new registrar".

Although our **Stamp Chairmen** were not present, and a report was submitted, Ed Moser had a question about how much the stamps made. His interest came from the four boxes he brought as donations. They were given to him from a gentleman out of Burns who had a fairly extensive collection. The information about the collection and the gentleman's desire to know what they brought will be passed on to Ed and Aaron, so they can perhaps keep track and report back after their disposal. Janice VanCura stated that the collectors' stamps are usually put in an auction. She knows Aaron and the process that is used. Mike Rose suggested that if there were any series of stamps that highlighted rocks they could be put in a Federation Showcase. There was a discussion about how the stamps should be saved. It was pointed out that the cancellation is often desirable. Vicki Johnson suggested that perhaps the stamp chairs could put something in the newsletter explaining what stamps are most desirable and how to prepare them.

Supplies Position is open. Please reach out to others to see if they would consider taking on this position.

The **ALAA** letter included in the reports asks for input for a rockhound definition. Please take note of the information.

#### **NEW BUSINESS**

Credentials: Clara Walker was called on to report on the delegates. She stated there were nineteen with credentials from fourteen clubs and several to be voted in. She named the additional people and asked all to stand. She then made a motion to accept those representing their clubs as Directors and delegates. Susie Koppert

seconded the motion, which was carried. The final count was twenty-seven representatives from twenty-seven clubs.

Mike Rose of the Northern Idaho Mineral Club asked to let the record show that their club might no longer have shows or exist because of lack of members. Darrell Coyle suggested that clubs help each other as Hamilton and Hellgate have done in the past. A discussion ensued with suggestions about hiring folks from the local Mission to help with heavy work. There are also 4-H, Scouts and Church groups that are looking for ways to volunteer. Mike wondered if Federation people would do security if the Federation was paid for their volunteerism. He stated that members were leaving his club because it was all just business. They are trying to have activities. He is hoping to implement an idea for the club's live auction this year. A member could get an IOU to use for purchase power with the idea that repayment would be to work at the show. Clara stated that CORC almost doubled last year because they promoted field trips. Facebook was mentioned and Larry cautioned that there are some groups that are formed that are not part of our code of ethics, which can give us a bad name. Kat stated they had gotten down to eleven members but with the promotion of field trips and a gem fair booth, they have been rebuilding their membership.

Treasurer, Linda Harvey, reiterated the importance of getting a club's dues back to her within the required time frame. It allows the current membership to be listed in the Directory. She reminded clubs that dues are based on the previous year's membership, not the upcoming year. She stated many clubs were quite late with their payment. Umpqua Gem and Mineral and Columbia Gorge were late enough with their dues that there is a need for the membership to vote them back into the Federation. Ronna Watkins moved that the two delinquent clubs be reinstated into the Federation. Del Walker seconded the motion which was carried unanimously. Linda then stated that the information for the club and payment of dues is due by January first. Please pay on time, and with updates. The treasurer turns over to the AFMS the names of the three individuals to receive the AFMS newsletter, and members begin to get their NFMS newsletters sooner or with no disruption when dues are paid on time.

1st Vice President, Darrell Coyle, presented the Proposed Budget with a motion to accept the budget with the ability to move amounts within the budget as necessary. Susie Koppert seconded the motion. Jim Brain, as Financial Advisor for the Federation cautioned that the officers' expenditure should be capped at \$5000, so if money is being spent, be sure it is needed. A vote was then called for. The Motion carried and the budget was accepted.

**President, Larry Hulstrom** introduced the **slate of nominees for the 2022-2023** year and asked if there were any further nominations from the floor. He asked to accept the slate of nominees as presented. Walt Butler seconded and the motion carried. **Darrell Coyle-President, Jennifer Haley-1**<sup>st</sup> **Vice President, Lora Hall, 2**<sup>nd</sup> **Vice President, Judi Allison, Secretary and Linda Harvey, Treasurer.** 

# Resolutions and Operation Procedure Updates (Addendum V)

Mel Lambert of the Hatrockhounds took the floor and presented the Website Proposal: As stated in the resolution brought forth by the Hatrockhounds, because the Website contest has existed for a number of years and has been offered by the NFMS, we, the Hatrockhound Gem and Mineral Society move to include the contents of the resolution in order to create a concrete guide. Emmett Johnson seconded the motion. There was a question from Kat Koch about timing for publication in the Newsletter. Darrell Coyle stated that it would be reasonable to publish at the time of presentation. The vote was then called for and the proposal accepted.

**The OP** referencing the update of the inside front cover of the **Directory** was presented. Emmet Johnson moved to accept and Janice VanCura seconded. The motion carried with no discussion necessary.

In presenting the **Resolution** brought forth by the **Endowment Committee**, **Jim Brain** stated there were two elements which would each require a vote. One was to eliminate unnecessary or duplicate language. Jim made a motion to take care of that aspect. Jerry Northrup seconded and the motion carried. Jim then moved to add  $2^{nd}$  Vice President to the list as stated in the proposal. Emmett Johnson seconded and that portion was also carried.

The proposed changes to the operation procedures introduced by the ByLaws Revisory Committee were the next order of business. Ronna Watkins moved to accept the changes. Janice VanCura seconded. A discussion followed. Mike Rose asked what constitutes "appropriate". Judi Allison suggested it would be based on what is available in the budget. Darrell Coyle pointed out that we need to be extremely careful of our budget and commented that the majority of work done is by volunteers. The idea gives a monetary reward to one group rather than all or none. He felt it was not a good idea to open that door and expressed his opposition. Ronna

stated the difference between judges and other volunteers is that judges have to be at a show. If we hope to continue to have competitive cases we have to have judges, and there is a lot of training involved. Charise Ash made a point, "If you have a question of how your judges are using discretionary money, how do you trust their judging?" Larry mentioned that at least it is a way to acknowledge the judges. Linda Harvey suggested that if they desired, the judges could refuse the honorarium. Mike Rose asked how it would be divided. Judi stated it would be equal across the board. The vote was then called for. Motion was carried by a majority vote.

#### Announcements

- Mike Rose pointed out that it would be nice to have the meetings also on Zoom. Some clubs reimburse their directors and delegates at a charitable mileage amount which is currently fourteen cents. It is up to the individual clubs to decide what they will offer.
- Packets had been available and given out for the Billings Show to be held as an AFMS/NFMS Show August 3-6, 2023. The question was asked: Will there be a mid-year meeting? Most probably; either Zoom or hybrid.
- Judi reminded all the attendees about signing in with their current email.
- Mike Blanton asked where the trophies given out were listed. Page 31 of the Operation Procedures.
- Hidemi Announced that Roberta Hanson will now be in charge of the silent auction. There are banners and other items he and Tomomko will pass on to her. He also thanked everyone for their donations to the auction.
- Larry announced that Denise Harrison was now a member of the Rockhound Hall of Fame. Meeting Adjourned at 6:41pm.

## President's Report - Larry Hulstrom

We started last year in September by having to cancel the annual in person meeting and holding it via Zoom. The Executive Board members continued working via multiple emails, phone calls, and Zoom meetings as we began the process of recovery. Many thanks to the rest of the Board members for their work and support. The search began for a show host for 2022. We also started work on compiling a new directory for the NFMS which hadn't been published for two years and quickly found that many clubs had lost members, changed officers, and struggled to survive and recover on their own. We reached out to a number of clubs that we didn't hear from to discover that a few had disbanded. Over the coming months we continued to work with many of the clubs to help them come back.

Thanks to all of you that stepped up and volunteered your time in one of the many committee positions that make up the NFMS. Without your support we could not function. The Portland Regional Gem and Mineral Show Association's bid to host the annual meeting and show was accepted and planning was initiated. By springtime it was nice to see many club shows being listed in the newsletter. Many people reported that their shows were a big success. Let's hope this continues.

In May a hybrid in person/virtual mid-year meeting was held in conjunction with my local club show in Kennewick WA. In addition to the meeting we also held a judges training class for which Margaret Kolaczyk, AFMS President, was the instructor. Many thanks go to Margaret and the 11 new judges that graduated from the class. Our annual show was also successful with an increased attendance from previous shows. The mid-year meeting was somewhat lightly attended, but by that time the inflated economy and the price of gas was being felt by everyone.

Mr. George Last was selected as the AFMS Scholarship Foundation "honoree" for 2022. He is the Geology Research Coordinator for The Mid-Columbia Basin Old Natural Education Sciences (MCBONES) Research Center Foundation (Coyote Canyon Mammoth site) in Kennewick, WA. You will see him and the two graduate students from Central Washington University, who are the scholarship recipients, during the annual show or at the awards banquet in Hillsboro.

The NFMS Endowment Fund has suffered the same losses as everyone else's retirement accounts. Continued effects from the pandemic, stock market volatility, ongoing events in the Ukraine, and inflation have been felt by everyone. We are all hoping and waiting for improvements in all of these areas. Overall the NFMS remains solvent and in a good position to recover as we move forward.

The past several years have been rough on all of us and we have lost many beloved club members and fellow Rockhounds. From one of my earlier requests in the newsletter I have compiled the names of 38 people from 13 member clubs who have passed away the past two years. If there are others that you know of please provide me with their names so they may be acknowledged.

Let's continue to support each other and work to recover. Many thanks to the members of the Portland Regional Gem & Mineral Association for hosting the 2022 annual meeting and in-person show. Following completion of that show I will begin packing to attend the AFMS annual meeting in New Orleans. I will report back what I learn from that meeting.

# Endowment Fund – Vicki Johnson, Chair: Jim Brain, Financial Advisor NFMS Endowment Fund Committee

# 2021-2022 Annual Report

This past year we welcomed Vicki Johnson of the Southern Washington Mineralogical Society as our Committee chairperson. Also, if you remember at the start of the year, NFMS President Larry Hulstrom, following up on a recommendation made at the last annual meeting, used his authority to temporarily assign Jennifer Haley, NFMS 2<sup>nd</sup> vice president as a member of the committee. The committee still has a vacant secretary position. The duties of that position are currently being shared by Lyle Vogelpohl, committee treasurer, and Jim Brain, committee financial advisor.

The following is a summary Endowment Fund Committee activity for the year.

- 1. For a little background, monies in the Endowment Funds are split into two accounts. One, the Operating Account is a cash account used to cover the current year expenditure obligations of the fund. The other is an Investment Account where monies are invested in the stock market to generate income through dividends and share value growth. We periodically sell stocks and deposit the proceeds into the operating account. In February we sold \$20,000 of our invested assets and transferred the funds to the Operating Account to cover expected obligations for the remainder of the year. The account balance has been doing ok this year considering the market ups and downs that have occurred. The combined Endowment Fund accounts currently have a balance of \$267,641.83 which is down about \$23,000 from where we started the year. (For a more detailed breakdown of the activity within the two accounts see the attached year-end annual financial report.)
- 2. At the September annual meeting (via ZOOM) the delegates approved an amendment to the committee's operating procedures authorizing the carrying over of any unobligated spending authorization into the next year. This gave the committee a spending authorization of \$14,324 for the current year of which we used a little over \$10,000.
- 3. The committee fund advisor worked with Charles Schwab Investments to update the paperwork associated with our two accounts. Vicki Johnson was added as an alternate person authorized to make decisions regarding the accounts. In addition, the names of individuals previously authorized were removed.
- 4. In the draft 2021-22 NFMS Budget there is a line item of around \$16,000 titled "Interest from Endowment Fund 2020 and 2021 Fiscal Year" in the revenue section of the document. This was to ensure a balanced NFMS budget for the 2020-21 year. It was in anticipation that there could be a revenue shortfall because of Covid issues and the fact there would not be any show revenue within the budget year. In July the Endowment Fund Committee transferred \$5,000 to the NFMS treasurer to make

- sure there would be available funds in the NFMS checking account to cover expected NFMS expenditure obligations. These funds came from the Endowment Fund operating account and did not require the committee to sell additional stock to cover the obligation.
- 5. The committee has drafted two resolutions for consideration at this annual meeting to modify the NFMS by-laws and committee operating procedures to permanently add "membership on the Endowment Fund Committee" as a duty of the NFMS 2<sup>nd</sup> vice-president position. Details on both resolutions were published in the May 2022 NFMS newsletter, page 5.
- 6. As in the past the committee is continually looking at ways to use Endowment Fund monies to fund projects and programs that offer the most benefit to the membership of the federation. Because of NFMS income uncertainties this next year and stock market volatility caused by inflation and recession fears the committee has paused its efforts to identify new spending opportunities. We are still obligated to use Endowment Fund monies to offset the \$1.00 reduction in member dues approved in 2019 at the annual meeting which results in a continuing obligation of about \$6,000 per year for another two years.

The Endowment Fund Committee continues to take a conservative approach in managing the funds entrusted to the committee. Though we have hit a small bump in the road this year the long term future still looks good. We may have to tighten our belt this next year and make sure that our expenditures benefit the membership of the federation as a whole.

# Working on The Rockhound Definition to be Added to the Federal CFR Title 43 and the BLM-Mojave Trail National Monument Jennifer Haley, ALAA Vice President

For the past several years there have been sporadic articles in the newsletters of ALAA,

CFMS and AFMS about the importance for rockhounds to work together on creating a

rockhounding definition to be added to the CFR Title 43. What is in the current CFR Title 43 can't be changed, but we can add to it. There has been little to no response from the rockhounding community on this project. In borrowing a phrase, we are at a critical point between a rock and a hard place.

Let's bring you up to date. This August, the BLM-Mojave Trails National Monument stated publicly they have no intention of preventing rockhounding in the monument. That was music to our ears. The BLM wouldn't have arrived at that conclusion had it not been for rockhounds getting involved and staying involved in enough numbers and quality of public comments, which included submitting their routes to collecting. However, BLM also stated they don't know how to manage rockhounding in the monument, and are asking for the input from the

rockhounding community. BLM does report to the Dept of the Interior, which means BLM needs to come up with a plan of management specifically for our recreation. BLM has requested rockhound input about how much we will be allowed to collect, when and how in the monument.

It is important to remember collecting in this monument is a first, only because rockhounds got involved in the very beginning of the monument's planning. All current monuments do not allow collecting. If rockhounds do not submit suggestions for limits on collecting and how best to manage rockhounding in the monument, the BLM-MTNM management will have to. Since the BLM has asked us for our input, we need to become the mapmakers for our future in the MTNM. This is a first also, to be asked to be involved in setting regulations on public land, let alone in a monument.

This brings our attention back to the Federal CFR Title 43. It will be much to our advantage if we submit written language for our collecting limits rather than government doing it without consulting us. Please keep in mind that more than one definition can be submitted to the BLM- MTNM and for the Federal CFR Title 43.

If you don't think more limits are in our collecting future, it is time to think again. The state of Arizona for example has set a limit on how much a person can collect per day and annually of rocks, minerals and semiprecious gems. It will be so much easier and in our better interest if we set the parameters for recreational rockhounding, instead of feeling shocked later we had no choice in the matter. The sooner we can establish a rockhound definition, the better.

One of the ALAA officers spoke with two congressmen a couple of years ago about helping us introduce a rockhound definition to add to the CFR 43 in congress. They agreed. That conversation needs to be updated. Because it is an honor as it has always been in respecting the AFMS Code of Ethics, we are becoming recognized for our stature and public image by public land management. This is occurring by those of you who have come together to work in partnership with public land managers. You are showing them we are good people to work with, and that we appreciate and protect our heritage of natural resources as well while enjoying our recreation. Below is one proposal of what the Rockhound Definition could look like. Bear in mind, some states have already regulated how many pounds of rocks, invertebrate fossils and semiprecious gems one person can collect per day and annually. Feedback and suggestions please.

# Free Rock, Mineral, Common Invertebrate Fossils, Semi-Precious and Precious Gemstone Collection Limits

Rocks, Minerals, Common Invertebrate Fossils, Semi-Precious, Precious Gemstones may be collected on public lands managed by the Bureau of Land Management and Forest Service without charge or permit as long as:

\* The specimens are for personal use and are not collected for sale, barter or any other commercial purpose(s). to one five-gallon bucket plus one piece per day, with a total limit of not more than 250 pounds per year by one person. These limits are for rocks, minerals, common invertebrate fossils, semi-precious and precious gemstone.

- \* A group of people do not pool their yearly allotment to collect a piece larger than 250 pounds of rockhounding specimens.
- \* Collection does not occur in developed recreation sites or areas, unless designated as a rockhounding area by BLM or Forest Service.
- \* Collection is not otherwise prohibited or restricted and posted.
- \* Collection, excavation or removal are not aided with motorized, mechanical devices, including heavy equipment or explosives. Metal detectors are acceptable in areas designated by BLM and Forest Service.
- \* No undo or unnecessary degradation of the public lands occurs during the removal of rocks, minerals, common invertebrate fossils, semi-precious and precious gemstones.
- \* For specimens heavier than 250 pounds or situations not covered in the Free Rock, Mineral, Common Invertebrate Fossils, Semi-Precious and Precious Gemstone Collection Limits, person (s) must contact the appropriate BLM or Forest Service office.
- \* If more than 250 pounds of specimens is wished to be obtained, or in situations not covered in the, Free Rock, Mineral, Common Invertebrate
  Fossils, Semi-Precious and Precious Gemstone Collection Limits, person (s) must contact the appropriate BLM or Forest Service office and inquire about arranging a permit.

The motion will read as follows: We, the Bylaws Revision Committee, move to add the following to the Operation Procedures under OP COMMITTEE-2, RULES & AWARDS COMMITTEE, PartA, General Duties: (Add subsection e) Assure appropriate honorarium be provided for participating qualified judges.

The rationale for this addition follows. Although the Executive Committee could simply assign an honorarium on a yearly basis, the above assures that judges are shown appreciation for their service. Because of the requirement for judges to attend the convention in order to carry out such duties, as was discussed at the midyear meeting, the above solidifies that assurance.

Each NFMS Executive Officer and committee chair also receive a copy at no charge. Directories may not be sold or transferred to individuals or organizations that do not have an inherent need to conduct NFMS business." (See Form I-Included in current Directory)

*Add to OP BOARD 3 1st Vice President* Serve as a voting member of the Endowment Committee *Add to OP BOARD 4 2nd Vice President* Participate as a nonvoting member of the Endowment Committee to learn the duties in preparation for the following year as 1st Vice President

**Background:** At the September 11, 2021, Annual NFMS Meeting it was suggested that the Endowment Fund Committee look into adding the 2<sup>nd</sup> NFMS Vice President position to the Endowment Fund Committee membership. The committee, at the time, discussed this and agreed with the suggestion. The addition would provide the incumbent an additional year to become familiar with committee activities as well as provide for more committee stability as the incumbent would now serve for two years on the committee. NFMS President Larry Hulstrom, using his authority to assign duties to officers, assigned the current incumbent in the 2<sup>nd</sup> Vice President position to the committee for this year.

## A Resolution to amend NFMS By-Laws

RESOLUTION ADDRESSING DUPLICATE TEXT IN THE NORTHWEST FEDERATION OF MINERALOGICAL SOCIETIES (NFMS) BY-LAWS AND OPERATING PROCEDURES.

Both Article X; Section 2, Standing Committees; Part (c) Composition of Committees, Endowment Fund Committee of the By-Laws of the Northwest Federation of Mineralogical Societies (NFMS) and the NFMS Operating Procedures OP Committee - 3. Endowment Committee section titled COMMITTEE COMPOSITION list the membership of the Endowment Fund Committee. This is unnecessary duplication and causes extra work and possible confusion when making changes to the committee composition.

The Endowment Fund committee proposes the following amendment to the NFMS By-Laws to eliminate duplication of text that is also included in the NFMS Operating Procedures.

Under Article X; Section 2, Standing Committees; Part (c) Composition of Committees, Remove the following: Endowment Fund Committee, shall be composed of: Chairman, Secretary, Treasurer, Financial Advisor, and NFMS 1st Vice President in its entirety.

The result is there would be no reference to committee composition in the by-laws. Committee composition is detailed in the operating procedures under OP Committee -3 Endowment Fund Committee, Committee Composition section.

The Endowment Fund Committee offers the following resolution to amend OP COMMITTEE -3, ENDOWMENT COMMITTEE to correct the title, remove extraneous text and add an additional member to the committee.

- --Insert the word **Fund** in the title of the section to read: OP Committee -3 Endowment Fund Committee
- --Remove the first line of text below the title line of the section which reads "Subject: Implementation of OP GENERAL -3" as the wording is not applicable to the section.
- --Under OP COMMITTEE 3, ENDOWMENT FUND COMMITTEE, <u>COMMITTEE COMPOSITION</u>: after the words NFMS 1st Vice President, add <u>NFMS 2nd Vice President</u>. The new text under <u>COMMITTEE COMPOSITION</u> would read: <u>Chairperson</u>, <u>Secretary</u>, <u>Treasurer</u>, <u>Financial Advisor</u>, <u>NFMS 1st Vice President</u>, and <u>NFMS 2nd Vice President</u>.
