Minutes of the meeting – 8-4-2023

President Darrell Coyle called the meeting to order at 1:08 pm. He then requested all stand for the Pledge of Allegiance.

Pastor Evan Day then offered an Invocation for the meeting to go well and be productive.

Darrell then introduced the individuals at the table: 1st Vice President Jennifer Haley, Himself, Second Vice President Lora Hall, Parliamentarian Evan Day, and Secretary Judi Allison.

Jennifer acknowledged the Past Presidents who were present: Ronna Watkins, Larry Hulstrom, Ken Zahn, Doug True (Also AFMS Past President), Judi Allison and Lauren Williams who was not in attendance. She also introduced Cheryl Neary, current AFMS President.

Darrell let the membership know about the undue passing of our Treasurer Linda Harvey. He then asked for a moment of silence for all the rockhounds we have lost this past year.

Lora Hall took over the microphone and moved around the room for the balance of introductions. Clara and Del gave the initial number of clubs and Delegates as fourteen and nineteen. With the addition of people who forgot their credentials, the count was twenty clubs and twenty-nine delegates. Larry Hulstrom moved and Michael Rhodes seconded the approval of the additional un-credentialed members. Their motion carried with a show of paddles.

Parliamentarian Evan reminded President Darrell there needed to be a vote to accept the agenda. Jerry Northrup moved and Heather Barber seconded to accept the agenda. Approved by a show of paddles. The matter of Miles City Gem and Mineral Club being accepted by the membership was brought forward. Joshua Hulstrom moved and Mike Blanton seconded the motion to accept the club. Ken Zahn interjected appreciation for all the efforts Doug True has taken to help form new clubs and bring them into the federation. The unanimous show of paddles was followed by a round of applause and a welcome.

Committee Reports with additional information follow.

Judi Allison requested folks consider the possibility of serving as Treasurer. She stated a more competent replacement is needed. She is better with words than numbers.

Jennifer Haley introduced the proposed budget as it was written in the packet. She asked for a vote to accept the proposal with the ability to move funds within the budget as needed. Kat Koch moved to accept the budget as written and Doug True seconded the motion. Proposed budget was approved.

Bulletin Aids and Website Contest Chair **Kat Koch** encouraged folks to enter the contests. It is a way to earn recognition and learn about how you can improve you publications.

Darrell thanked Del and Clara Walker for their many years of service as Credentials Chairs.

Neither Jim Brain nor Vicki Johnson of the **Endowment committee** were able to attend, thus had asked Jennifer Haley to speak for them. She reported that since the report was printed, our investment portfolio has grown \$2500. The income shown in the proposed NFMS operating budget coming from the Endowment Fund, will obligate the spending authorization for 2023-2034, based on the 4% spending policy. There is hope things will be better this coming year, and Endowment Funds won't have to be used to cover basic NFMS operating expenses. The intent of the committee is to use "funds" to fund projects and programs that offer the most benefit to the membership of the Federation. This is what the committee loves to do, but due to financial unsteadiness from the pandemic and offsetting of dues it hasn't been able to.

Doug True reported about the Blue Forest Federation field trip in May. There was also a second trip to Tepee Canyon, South Dakota in June. Fourteen Billings members went this year. He plans to offer this trip next year also. There was a comment about buckets of rocks, and retired Forest Service personnel, Janel Lacey pointed out five gallon buckets only applies in specific regions. The rules state incidental amounts of wood/rocks. Doug stated in South Dakota the five gallon buckets are allowable.

Nominating Chair Larry Hulstrom introduced Michael Rhodes as our 2nd Vice President candidate. **Susie Koppert** spoke of the three and a half week circuit she has been on listening to and talking to many geologists. Write and tell those making the decisions why you do or don't like whatever thing is going on. Susie stated her uncle was a retired geologist who spent years in the mining and energy exploration and that she has had many conversations with him. She stated the Oregon Council has voted to do a write up on how to get into collection areas. She had copied maps and information for each club to take and study.

Laurie Ellis stated that her email had been changed to the correct one to use in the Newsletter. Some people queried what Rockhound of the Year was. As AFMS Chair, Judi Allison explained that is a simple method for clubs to honor one adult and one Junior member each year. It is not a contest. There is no specific criteria a person has to meet. It is simply an honor. A member of a club, the executive committee of the club, a nominating committee or perhaps last year's recipient might be the one to choose who to honor. There is a list of regional Chairpersons—Laurie being the one for NFMS. When a write up is sent to Laurie she will send it on to the AFMS Chair (Judi) who will create a certificate to be presented to the club's honoree. The write up will also be published in the NFMS and AFMS Newsletters.

Rules and Awards Chair **Josh Hulstrom** (and Larry) were given a thank you from Darrell for digitizing all the information so that it will be more hands on in the future. They explained that the Rules and Awards Committee agreed to break down the rules into different sections in order to make it simpler for potential competitors to read and decipher.

Darrell stated that **Faith Farley** has now taken over the Show Coordination position.

Ronna Watkins is now officially serving as Chair for the Library. She stated it seemed a good idea so that nothing had to be moved. The process of digitizing the slide library is ongoing. A quicker, more efficient way has been discovered. Ronna reminded folks to send back the material per media mail (with insurance) to save cost. And she encouraged folks to please take care of our stuff.

Although Stamp Chairs Aaron and Ed were not present, thanks to mostly the Idaho Gem Club (and some others) there were two large boxes of stamps to be delivered. Thanks to Rich Holt and Del Walker for volunteering to get the stamps to them so they can "work their magic."

Darrell stated although we need a new chair, he had a few supplies in his possession. Perhaps the tee shirts and hats could be brought out at the show in Hermiston next year.

Jennifer Haley spoke for the American Land Access Association (ALAA.) She stated that the phrase "working together" has been really pushed this year. ALAA works to have folks contact as many as possible about issues that are relevant to our hobby. She thanked those who went out of their way to write letters. Please stay involved. There will be a meeting on Sunday at one. There will be a live auction following with a 50/50 benefit for ALAA and NFMS general fund. Janel Lacey informed those present that when writing letters one needs to give a substantive comment. Identify an action of concern and what effect it has. It was suggested Janel write an article for the NFMS Newsletter. Doug True reminded that a club should not send the same letter. Janel stated the letter needs to be professional. Roger Burford, AFMS President elect asked that Janel's article be shared with all the Federations.

Darrell reminded the Directors and Delegates "You are our pathway to our clubs." Jennifer's new guide for New Directors is on the web site. Remember to send changes. Keep us updated.

Old Business

Newsletter-Electronic or printed and mailed?

Darrell gave an overview of reasoning to move to an electronic paper. Postage and printing have gone up. It is now approximately \$2500 per issue. The Bylaws state a minimum of six and maximum of ten a year.

Evan Day stated that there does not need to be a vote, but we want the membership to have a say whereby with discussion an electronic version would be phased in if the concept passes. The format would change so it could be easily read on even a phone. Clubs would need a reliable person to receive and disseminate the electronic version.

Doug True stated balancing and spending is equally important. Some clubs say it's too much money. Doug says it is a draw-written newsletter-field trips.

Ronna Watkins pointed out one can already access it on line. People wouldn't be getting anything for their dues without the printed version.

Ann Tolley asked if it is more difficult to forward to responsible people than to circulate an electronic copy to all from one source. There was some discussion about programs that allow sending large quantities of email in a bulk form. "Mail Chimp" was mentioned. (Heather Barber of the Northern Idaho Club sent Secretary, Judi an email with a source that will do just that.)

Clara Walker stated that Tom Burchard (Circulation) can only do what he can do. There seems to be a breakdown in responsibility when folks are not getting their newsletters. She has a passion for newsletters. What are funds for if not for written newsletters?

(It was noted that the offset of a \$1.00 for adult dues will be coming to an end. The adult dues will again be \$3.50 per person.)

Michael Rhodes said he has never received a written paper. He gets it electronically and that is how it is sent to all in his club. In the eight years he has been in the Federation only two people wanted a printed copy in the Golden Spike Club. He's ready for the electronic age. Perhaps charge extra for the printed version.

Janel Lacey agreed that an electronic version makes sense. In the fifteen years in her club there has been some breakdown in the process because even if done correctly in their club, not all get it. The NFMS can support clubs as it is worked out and we share more.

Cheryl Neary (AFMS President) stated in the Eastern Federation not all have internet access. When they went digital, clubs asked for money back. Most Federations send out papers to only three designated members of each club. The same is true for the AFMS. There are pros and cons to all. She doesn't personally like electronic.

Ken Zahn is a strong advocate for maintaining the paper in print. He sees two problems: getting members reported and finding out why members are not receiving the newsletter. He is a member of sixteen different clubs. The newsletter is a unique asset of the NFMS. Clubs will baulk; especially any club trying to grow or rebuild. The endowment fund is not in jeopardy because of the newsletter-Ken challenged that premise.

Doug True stated that "old folks need paper. Billings has electronic but anyone who wants a hard copy can get one.

Tony Fender shared that California (CFMS) sends three Federation newsletters to each club. A few years ago the question of electronic or hard copy came up. Two-thirds chose to go electronic.

Michael Richards suggested that clubs could print hard copies for their meetings.

Michael Blanton wants paper-or at least a format for a mobile device.

Heather Barber would like an option of print or email.

Roger Burford said why not get the newsletter on a website that just has authorization for the clubs? **Jennifer Haley** stated there is so much more than just the newsletter for the Federation; great contests and such. Money saved could be used in other ways. What are we going to do with the money? The endowment grew because of clubs donations. It is not made for emergencies. We all know how to tighten our belt when necessary. Working with the BLM is an example of how we can work together on the behalf of all rockhounds. The same is true of the AFMS.

Lora Hall Mirrored Jennifer. The AFMS taps into the endowment funds to pay for all Junior programs and there are other benefits. There was even a club that left the Federation that asked for a badge; which they lost out on.

Judi read input sent from Audrey and Lyle Vogelpohl who were unable to attend. They both strongly voiced their objections to an electronic newsletter. Lyle cited the by-law that states "maintain the Northwest Newsletter as a medium of DIRECT CONTACT (under newsletter op bullet two.) He mentioned that at one time only three people in each club received one and information was not disseminated. Audrey pointed out that (under Fund Management-Expenditure Identification-A.1.) stated that projects should be for the general benefit of the NFMS membership or its member societies-not for a select few or to cover individual costs in the budget. Judi Allison also stated it works both ways. We do need better communication.

Darrell determined that it was not time to call for a vote. He suggested having an option for clubs to decide. We can't satisfy everybody. Things are not going to get any cheaper.

Michael Richards said it was a great idea but even better would be to make it a benefit to go electronic.

Janel Lacey stated there are many reasons why people want paper copies.

James Finckbone threw out a motion that each club have an internal discussion to go electronic.

Janel Lacey, with prompts from others, then created a motion to have clubs go electronic with the Northwest Federation Newsletter, and if they choose to do so get a reductions of \$1.00 per person. **Michael Richards** seconded. After some confusion and interjections and a comment from Darrell, it was amended that clubs that go with paper pay extra rather than a discount for electronic.

Roger Burford interjected that you are already paying for a newsletter. Why would you want to pay more? **Ken Zahn** threw in an objection that paying more dollars is not okay.

Michael Richards stated if it is only a change to print or electronic there would be no by-laws change. Tammy Rydal asked if it is shifting responsibility to individual clubs.

Mike Blanton reminded about the past comment that if there were less copies of the printed paper the cost goes up.

Darrell then restated the original motion omitting any mention of money. "Allow clubs to opt out of a paper newsletter if they choose to do so." He asked Janel if that motion stood as an agreed upon phrasing. She agreed, and with that a show of paddles was called for. Nineteen for the motion, seven against and three abstaining.

(A Comment from your Secretary: In essence, this entire exchange has changed nothing other than making the executive committee more aware of some needs of better communication between the clubs and those in leadership positions so that everyone will have the correct information to help each society run smoothly and share information back and forth. The newsletter will continue as a hardcopy missive with distribution to individual households.)

Larry Hulstrom then took up the matter of Nominations. He introduced the slate of candidates and asked for any additional nominations from the floor. President Jennifer Haley, 1st Vice President Lora Hall, 2nd Vice President Michael Rhodes, Secretary Judi Allison. Receiving none, the nominations were closed and the slate of officers for 2023-24 were accepted by acclamation.

As a matter of business Larry Hulstrom has been appointed as the new Registered Agent, thus the principal place of business will change from 8810 37th Ave SW, Seattle, WA 98126 to 5409 W 26th Ave, Kennewick, WA 99338. The Articles of Incorporation Article II and Article I Section 2 of the by-laws will be changed to reflect the new address.

AFMS President Cheryl Neary thanked the NFMS Federation for holding the show. She also thanked Jennifer Haley for creating wooly mammoths as a fund raiser for the Junior program. She thanked Lora Hall for all the work she has put in as the AFMS Junior Chair. She thanked Judi Allison as NFMS Chair for the AFMS Endowment fund and suggested Judi still had some tickets to sell. She also thanked Larry and Josh Hulstrom for all work they put in on Uniform Rules. She ended by saying Billings is a beautiful city. She drove from New York and is enjoying all the sites.

Michael Rhodes moved to adjourn and Larry Hulstrom seconded. The meeting was adjourned at approximately 4:20 pm.

REPORTS FOLLOW:

President's Report – Darrell Coyle - President's End of Year Report

As the First Vice President, I reviewed the Treasurer's reports and the Endowment Fund Reports for the previous two years to be able to write a proposed budget for this year. It really stands out that the Newsletter is the largest single expenditure and that income is not matching the funds spent. That is the main reason that I have pursued changing to an electronic Newsletter for the NFMS. I feel that there are other better ways to use our funds to improve the NFMS: digitizing the NFMS Library; possibly being able to ask for less from the revenue of Host Clubs that sponsor the Annual Meetings. Communication between Club Directors and the Executive Board needs to be improved and Club Directors need to know what their responsibilities are. I have tried to be open about this and keep the membership informed through my articles. I hope by the end of my term these things will be in motion.

I have full confidence that the incoming President, Jennifer Haley, is going to be able to finish these goals and be an outstanding President. She is very upbeat and a great communicator. The Second Vice President, Lora Hall, is also a tremendous asset to the NFMS. Her work with the AFMS Junior's Program has been very much appreciated. Past President, Larry Hulstrom, has been invaluable for his advice and willingness to take on some

of our most important issues. Huge Thank You to our Executive Secretary, Judi Allison. Without her knowledge and devotion to the myriad of tasks she does the NFMS would certainly be at a loss.

The majority of those that will be reading this are Directors and Delegates from our Member Clubs. You are key to the success of the NFMS. You need to keep your members informed and educate them on what the NFMS and AFMS do on their behalf. Keeping contact information and responding in a timely manner to changes in your club leadership and ensuring that dues are remitted on time is important so that the Board Officers and Committee Chairs can perform their jobs.

At each Annual Meeting we have a moment of Silence for those members that have passed during the year. Recently the NFMS lost our Treasurer, Linda Harvey. She was involved in many clubs and organizations as their Treasurer or Secretary. This has placed the NFMS in the unusual position of needing a new Treasurer immediately. Please consider taking this position or nominating someone.

I will continue to work for the NFMS in the future. As the Immediate Past President and then as a member of the Past Presidents Council. I will continue to be available to all of you. Thank you to all who have listened, advised and supported me during my time as an Officer of the NFMS. I do hope that you will enjoy the Show and take advantage of the activities. The Members of the Billings Gem and Mineral Club have worked hard to put this together for the NFMS and AFMS and its members. Thank you.

Secretary's Report – Judi Allison

This has been a very busy year. It has included addition of new volunteers, changing of the guard for some, addition of a new club, loss of some clubs and sadly, loss of some dear rockhound friends. But we all keep forging on. The executive committee has been very active. Discussions have been ongoing about membership, visibility, educating our clubs and volunteers about their roles within the Federation, and finances. One of the top priorities relevant to finances has been the discussion around implementation of an exclusive on line version of the Northwest Newsletter. In our age of technology, it only makes sense. I recall when I first became active in the Federation twenty-five years ago, the fact that the NFMS was the only Federation to offer a hard copy of the Newsletter to every household held a sense of pride. Today, with the rising costs, people's access to technology, and our changes over the years, the idea seems almost foolhardy. The newsletter is the single most costly item within the budget. With the money saved by an online version, the slide and video library could be completely updated, judges could possibly be offered a set monetary stipend, a possible offset of dues could again be implemented, field trip organizers might be able to receive some money for mileage. A number of things to benefit the federation could be accomplished with funds saved from such a change. We have researched and found that the change can be made by a simple revision of the by-laws. There is not a need for any formal resolution. The idea could be accomplished at our annual meeting by a simple motion and a vote from the assembly of directors. Consider what this could mean for our Federation as a whole. Remember, each one of you is a part of the Federation, and you have the power to make the decisions that make sense to carry us into the future.

As always, I truly enjoy working with the members of the Executive Committee, as well as, all the great rockhounds within the individual clubs. I look forward to continuing in my capacity of Secretary as long as you want me around, and I am able.

NFMS Treasurer, Pro Tem-Judi Allison

As I would guess you all know by now, very sadly, we lost our Treasurer, Linda Harvey in June. With such a sudden occurrence at a time when she was preparing for the upcoming meeting and end of the fiscal year, it left us scrambling to get things in an order to keep business going. Thanks to Bill Harvey, Linda's husband, and the Executive Committee, especially Larry Hulstrom, for helping to pull all together so we can move on. I have agreed to act as the Treasurer, pro tem until a replacement can be found. But, as I have told the Executive Committee, I am good with words, not numbers. If you love computing with numbers, please consider taking on this essential role.

Although, sadly, Central Oregon Rock Collectors, Cache Rock and Gem Club and Spokane Rocks Rollers chose not to renew their membership this year; happily we have gained the Miles City Gem and Mineral Club. We welcome them with open arms.

2023 Annual Budget Report-1st VP, Jennifer Haley (See ADDENDUM III)

As the NFMS 1st VP, I am responsible for preparing the budget for 2023-2024. The proposed budget is always presented to the NFMS Executive Committee and the NFMS Endowment Fund Committee for their eyes and minds to critique, before being presented and proposed at the Annual Organizational Meeting.

I've learned a lot this year with the patient help of many people's wisdom and experience, about all the considerations which go into a budget for our federation. A lot of considerations go into the pot called the Budget, and we stir it until we feel we've got the recipe right.

We estimated our spending limit for 2024 will be \$10,500 in order stay within the 4% Endowment Fund Spending Policy. We are already committed to spend \$5,278 of that to offset the \$1 per member dues reduction which the federation began in 2019 to help our societies during the pandemic. The five-year dues reduction commitment ends at the end of 2024.

The challenges we have been working together on for next year's budget, concern working with the impacts affecting our annual revenue. These include the dues reduction, loss of a few societies, navigating the everchanging world when it comes to the various aspects of the economy and coming out of the pandemic, and the potential cost increases which can arise during the functioning of a normal business year like printing, postage, insurance policy increases, travel mileage.

Under the suggestion of Jim Brain-Endowment Fund Advisor, you will note under Revenue, two line items have been retitled.

Interest from Endowment Fund is retitled; Proceeds from the Endowment Fund.

Interest from Endowment Fund-Dues Offset is retitled; Proceeds from the Endowment Fund-Dues Offset.

These suggestions were made because besides interest, these funds also include stock dividends, capital gains and value growth of the invested stocks.

Following the AFMS/NFMS show/convention in Billings, most likely in the month of September, the NFMS Executive Committee is looking forward to having an educational Zoom meeting with the NFMS Endowment Committee about the groundwork that goes into working on the annual budget. This will be a great way to lay the groundwork which will help not only our incoming 1st VP, 2nd VP and new Treasurer, but for all of us as the NFMS officers as we move forward working together into the coming year.

NFMS Annual Report Club-at-Large 2023-Jennifer Haley, Chairman

At the time this report was written, the federation currently has 27 members. The purpose of the NFMS Club-at-Large is to provide membership to individuals who, for whatever reasons, have no "home club," and to whomever wishes to belong. Members in good standing of the NFMS Club-at-Large shall have all the rights and privileges of the NFMS

2023 NFMS Endowment Fund Committee-Annual Meeting Report

As the country's financial situation has started to stabilize and inflation appears to be lessening, the Endowment Fund's financial situation is starting to stabilize. The stock market trend has generally been flat for the past 8 months but recently has started showing a slight trend upward. Your Endowment Fund Investment Account portfolio has weathered the market volatility and currently has a balance of around \$265,000, up around \$11,000 (4.6%) this business year. However, over the past year the fund growth has been slightly less than the fund expenditure. Generally, we have been able to stay within the fund's spending policy of obligating no more than 4% of the average of the year end balances for the previous three years plus any unspent authorizations carried over from the previous year. (The shortfall this year is because we had a higher spending authorization caused by carryover from the previous year. More specific details about the Endowment Fund status can be found in the attached financial status report.)

Because the value of our invested portfolio dropped significantly last year due to the fall in the stock market, we have not been able to fund any new programs or activities this year. As a result, the primary activity of the committee has been to work closely with the NFMS treasurer to make sure funds are available to cover operating expenditures of the federation.

The committee started the year with slightly more than \$20,000 in the Operating Account. Last September, after consultation with the NFMS Treasurer, we transferred \$10,000 from the operating account to the NFMS treasurer to cover a NFMS cash flow shortfall expected until club dues payments started coming in later in the business year. Part of this fund transfer was a payment in advance to cover the \$1.00 per member dues reduction that would be due in January. This left an Operating Account balance of around \$10,000. In late March we transferred another \$5,000 to the NFMS treasury to cover income shortfall due to a general drop in federation club membership and some clubs leaving the federation. The current Operating Account balance is a little over \$6,000. This will be held in case the NFMS Executive Committee identifies emergency expenditure needs between now and the end of the business year.

The committee financial advisor will be monitoring the performance of our invested stock portfolio to determine what the spending authorization for next year will be. Unless there is a big jump in the market between now and the end of the year, it looks like the fund will be authorized to spend around \$9,500 next year. (There will be no carry over un-obligated spending authority from this year.) We know we will have an obligation to cover the final year of dues reduction which is estimated to be around \$5,000. This leaves only \$4,500 to cover other fund spending obligations. Until we find out what the financial situation of the federation itself looks like the Endowment Fund Committee will not be looking for other programs or projects to fund.

Donations to the endowment fund from member societies and individuals have exceeded previous years, thanks to a very generous donation from an individual couple. To date donations have totaled \$1,125.00. The committee continues to encourage member societies to consider making donations to the endowment fund as a good will gesture or in memory of deceased members.
