President, Ronna Watkins presided over the meeting. Notes taken by Gayle Butler in the absence of Secretary, Judi Allison. Notes transcribed into minutes by Judi Allison.

Past Presidents were introduced. Those in attendance were Paul Heesacker, Chuck Sonner, Lauren Williams, Lyle Vogelpohl and Hidemi Kira.

Following are the written reports with additional information (in italics) outlining information related during the meeting.

President's Report - Ronna Watkins

I had the honor to represent the NFMS at the American Federation of Mineralogical Societies' Annual Convention in conjunction with the Midwest Federation's Annual convention and show hosted by the Cedar Valley Rocks & Minerals Society in Cedar Rapids, Iowa March 21-24 at the 2019 AFMS Meeting.

I attended all the meetings: AFMS Rules Committee, AFMS Annual Meeting, Scholarship Foundation Meeting, ALAA Meeting, MFMS Annual Meeting, and the Editor's Breakfast.

From the NFMS we memorialized Mel Wilks, Hells Canyon Gem Club, April 2018, Richard Clark, Idaho Gem Club, April 2018, and Richard Neal Thomas (Dick Thomas) Golden Spike Gem & Mineral Society, August 5, 2018. These were the only names submitted from our clubs. Here are the items important to record:

- NFMS Past President, Doug True, from Billings MT presided as AFMS President.
- James Bosley was elected as AFMS 5th VP.
- AFMS newsletter editor, Carolyn Weinberger passed away, March 25, 2019.
- Sue Webb will be the AFMS Newsletter Editor and Cheryl Neary will become the new Central Office after November 1st.
- AFMS Scholarship Foundation, Inc.: \$48,000 is awarded each year to graduate students (Two \$4,000 scholarships in six AFMS regions.) As of 2015, 610 scholarships have been awarded at 132 universities totaling 1.7 million dollars in awards. Sandie Fender of the CFMS will serve as our new AFMS Scholarship Foundation Chair.
- The AFMS 2020 Convention will be held in Knoxville, TN in October and the 2021 AFMS Convention in Sandy, UT.
- Several NFMS contest entries into the Editor's and Website contest received recognition.

As NFMS President I am honored to work with very capable, knowledgeable, and proactive, enthusiastic leaders. Thank you to our chairpersons for their commitment to the NFMS. We still have some chairs to be filled.

Since our 2018 Annual Meeting we have held an Organizational Meeting in Lewiston. The NFMS has been busy updating operation procedures, aligning our chairs to the AFMS,' and generating much needed handbooks.

As voted on by our membership, we have up-dated our investment policies to conform to the requirements of UPMIFA by developing a written spending policy protecting our endowment fund's long-term viability, and changing our definitions of restricted and unrestricted funds explaining how each is to be managed and used.

Endowment Fund: Our membership has approved an Endowment Fund Spending Policy that authorized an annual expenditure of Endowment funds equal to 4% of the average three year fund balance. It is estimated that this will make about \$10,000.00 per year available to spend.

We have added the Special and Memorial Trophies to our OP's.

We now have a Judges' Manual, a Manual for Hosting NFMS Shows, and a "List of Museums" in the NW of interest to rockhounds.

Thank you to Jack Edwards, Jim Brain, Judith Allison, Linda Barlow, Ken Zahn, The Golden Spike Gem & Mineral Society, and Lauren Williams for their work on these items.

I would also like to thank Linda Barlow for taking on the job of Editor Pro-temp and producing our *Northwest Newsletter* in the absence of a permanent Editor.

Our 2019 show and convention hosted by the Hells Canyon Gem Club of Lewiston, Idaho will be held October 18-20, 2019 at the Nez Perce County Fairgrounds.

Secretary's Report - Judi Allison

I am sorry to miss the Mid-Year Meeting this year, but I do have to admit that I am not sorry to be flying to Atlanta, Georgia at that time. I am a CASA (Court Appointed Special Advocate) and I have the opportunity to attend a National Conference. NFMS Treasurer-Lyle Vogelpohl One Club has requested to join the NFMS. Lewis County Rock and Gem Club has been given conditional membership pending official vote of the Assembly of Directors at the Annual meeting. The club has eighty members. A club in Salmon Idaho has also requested membership information. Lyle reported that Sandy Hanson, Magic Valley Gem & Mineral Club, raised another \$250 thru Walmart's "Volunteerism Always Pays" program; has to date raised \$2,500 thru her efforts. He reminded those attending that all Walmart workers can sign up for the program. Other companies have this benefit as well.

1st Vice President Ken Zahn's Oral Report, Mid-Year NFMS Meeting, June 1, 2019

- 1. ALAA Support:
 - Elected as a Director at 2019 AFMS Meeting.
 - Reviewed and advised on California Federation's comments and protest draft to the WMRNP_LUPA_Final SEIS and associated Travel Plan.
 - Advised several groups and ALAA on NEPA process for commenting on draft BLM environmental review documents.
 - Reviewed and discussed ALAA Bylaws and OPs with President.
- 2. Drafted 2020 Budget Call email message to solicit comment and budget requests from Officers and Committee Chairs; coordinated draft with Treasurer. To be sent out after discussion at Mid-Year meeting.
- 3. Travelled to Golden Spike show in Ogden UT to discuss issues of circulation of paper copies of NFMS Newsletter with Circulation Chair Tom Burchard. Discussed issue with President, Treasurer, Secretary, Directory Chair, and President of the Bitterroot Club. Reviewed circulation-related draft clarifying texts for Newsletter.
- 4. Attended shows of AFMS, Helena (non-member of NFMS), Golden Spike, Idaho Falls, Bozeman, and Bitterroot clubs, and will attend North Idaho and Butte club shows in June.

- 8. At this year's Golden Spike Club show, I discussed the potential for Golden Spike, UT, club to submit an application to host the 2020 NFMS Show/Meeting on Easter weekend, 2020.
- 9. Plowed snow all winter; first mowed lawn May 29th; browsed for antiques in Iowa; continued as Sr. Trustee of a valuable museum collection owned by the Bozeman Gem & Mineral Club; passed a kidney stone; and got older May 27th.

Endowment Fund – (Chair Position Open) Jim Brain, Financial Advisor

A summary of the financial status of the Endowment Fund will be available at the meeting. We are on track to being able to spend \$10,000 from the fund next business year and will continue searching for the best possible uses of the funds. Also we will continue to beat the bushes to find a new committee chairperson and Secretary.

Jim reported that our investment balance was \$283k, but now it is \$254k. This is up \$12k from last year. Ideas are needed that benefit the NFMS along with the cost of the ideas proposed. \$4k is available (4% of the last 3 year average is used to make up the Endowment Fund unrestricted funds.) Hidemi Kira suggested traveling display cases to show specimens from a particular area. It would start new each year. Other suggestions included the possibility of giving help to clubs sponsoring an NFMS show to pay for a special speaker or display, etc. Mindat.org doesn't meet the criteria. Rice Museum is a possible recipient if they had a special project.

Field Trip - Doug True Doug will put together a field trip next year after his AFMS Presidential and ALAA terms are over.

Historian - Linda Barlow

This year has been slow with responses to the local and state Museum listing I requested from each club for the NFMS listing. I am continuing to work on this. I started with Alaska as that is my trip for this summer. Looking forward to seeing these museums!

This is a slow process as there are many museums in each state posted in an overall listing without noting an application to Rocks/Gems/Mining/Fossils/Artifacts/Lapidary Items. This has required me to call each museum and talk with the curators for information on possible displays of items applicable to the Mineral Societies population. This has been a great learning tool for me and loved talking with the museum curators in the different states.

The Museum Listing cannot be on website until all states are completed. The list is now complete and submitted to the Webmaster for inclusion on the site.

Following is a list of Nominees for the NFMS Executive Board for the term Sept. 1 2019 to August 31, 2020. *President, Ken Zahn.* I am honored to accept the nomination for the Presidency of the NFMS for the 2019-2020 Federation year.

Ken began prospecting and collecting minerals while studying at the University of Arizona from 1954-1960, where he attended on a Track scholarship and majored in both Education (BS in 1959) and Chemistry (BS and MS in 1960). He served 26+ years in the Army, earning a PhD in organic chemistry (U of Illinois 1964-1967), teaching at the US Military Academy at West Point, commanding the Army's large crime laboratory in Georgia, analyzing foreign intelligence documents, and serving in nuclear missile units in Germany, aviation units in Vietnam, as well as doctrine-development and equipment-testing units in Panama, Alaska, Europe, Utah, California, and Maryland. He retired in 1985 as Deputy Commander of the US Army Chemical Research and Development Command complex at Edgewood Arsenal in Maryland. In retirement, he has taught chemistry at Utah Valley University and worked 20 years for the University of California at Lawrence Livermore National Laboratories as an Environmental Evaluations Group Leader and Program Manager. Since 1972, he has been a member of 12 different gem and mineral clubs in California, Georgia, Maryland, Pennsylvania, Utah, and Montana, and has served in many leadership and collection-trusteeship positions in the Bozeman Gem and Mineral Club since 2004. His main hobby interests are field collecting, studying pegmatites, speaking at schools and meetings, and participating in NEPA reviews of Forest Service- and BLM-proposed Management Plans, Travel Plans, and Regulations. He is a big supporter of balanced use and increased motorized access for partially disabled and older forest recreational users. My husband, Paul, also rockhounded as a teenager. In 2001 we decided to give the hobby a try again and joined the TVGC rockhounding club and became active there. I learned how to form cabochons, tumble rock and make jewelry. I have found that the best way to learn is to be active in the hobby based club so I volunteer as much as possible.

We later joined the Clackamette Mineral and Gem Club and have been very happy and active there too. To support the search for the rough material I also started to study geology. That turned my interest from lapidary work to minerals and now I have an extensive collection of cabinet to micro minerals that takes up a large portion of my house. I love the beauty and the intricacy of the forms and the chemistry of what I find.

As editor of the NFMS Newsletter (retired), our rock club's Clackamette Gem and the Newsletters for the Pacific NW Chapter of the Friends of Mineralogy and for the National Friends of Mineralogy Bulletin; I have learned about the inner workings of the groups and have helped support their outreach concerning our hobby.

Larry's interest in rocks began as a child on the southern shores of Lake Superior in Michigan looking for Lake Superior agates and freezing in the waters of the lake. An interest in dinosaurs during grade school and his families move to Ann Arbor resulted in his enrollment at the University of Michigan in the geology department where he studied paleontology and furthered his love of rocks and fossils. (He is also a staunch MI Wolverine fan!) Graduate school at Michigan Technological University in Mining Engineering furthered his collection of native copper and resulted in the start of his professional career at the Hanford Nuclear Reservation in southeastern Washington working on a project to determine the viability of nuclear waste disposal in a geologic repository in basalt.

After cancellation of that project, Larry shifted gears and moved into the environmental restoration field where he spent the remainder of his career.

After marrying his wife Kay and having two sons, Joshua and Jason, the boys showed interest in Dad's collection as they were growing up. This resulted in Larry joining the Lakeside Gem & Mineral Club in Kennewick WA where he became one of the Junior Club leaders and got involved with the adult club in the early '90's.

Lauren spoke to the proposed changes to the OP Committee -2. These changes will comply with AFMS competition.

Safety – (Vacant)

ADDEDENDUM: CHANGES TO OP COMMITTEE -2 RULES & AWARDS COMMITTEE

Lewiston, ID October 19, 2019 (Presented by Lauren Williams)

I find nothing in the By-LAWS that need changing. Therefore no Resolution is required. All changes are to the OP's which can be done from the floor.

This does not affect anything that was voted on last year, 2018. Last year's voting established a new item 2 in Section 4, Memorial Trophy.

In Part A the first line (a) should be deleted. The Rules committee has nothing to do with non-competitive displays. And re-number the following lines accordingly.

ALL words "Chairman" is replaced by the word "Chair".

Green is what is to be changed – Red is the Justification

OP COMMITTEE -2, RULES & AWARDS COMMITTEE

Subject Duties of the Rules and Award Committee

PART A, GENERAL DUTIES

The Rules and Award Committee shall:

- *Administer the American Federation of Mineralogical Societies Uniform Rules in the NFMS and supervise their use at the Annual NFMS Show, as directed in the By-Laws.
- *Edit, publish, and make available the NFMS Supplementary (Remove word. I have never seen a supplementary rule, only the rule book. A proposal is not a rule) Rules for show competition, pursuant to provisions in the AFMS UNIFORM RULES. These will provide for:
- (a) Provisions for non-competitive display. (Remove line. The host society is in charge of all non-competitive displays and all of the floor space they occupy on the floor. We just tell the host society how many competitive displays we have after the deadline for entry is met. The host society decides where to put the cases in with the rest of their displays).
 - (b) Listing of divisional awards and classes, plus special and memorial awards and trophies.
 - (c) Special Northwest classes available for regional competition.
- (d) Any interpretations or supplemental (Remove word. There is no official supplemental information only the one rule book), information available since publication of the current AFMS Uniform Rules Book, or reference to such information.
 - (e) Special rules for the show such as: (re-number the lines accordingly)
 - (1) Hours for placing exhibits.
 - (2) Opening and closing hours.
- (3) Instruction for leaving keys to exhibits for special judging situations. Change to, Faceting and Miniature Minerals.
 - (4) Any special circumstances not covered in the AFMS Uniform Rules. Typo.
- * Plan and provide Host Society with an exhibitor's registration form to be reproduced and included in the Host Society's information packet. (Delete sentence. Published in NFMS Newsletter. Only Host Society gets Host Society club newsletter, the rest of us have to get it in the NFMS Newsletter).

PART B, SPECIFIC DUTIES OF COMMITTEE MEMBER.

SECTION 1, RULES CHAIRMAN

Rules Chairman shall:

*Throughout the year, see that the work of the Rules Committee is being done on schedule and in proper fashion including that assigned to the Judging Director and the Exhibits Registrar (Exhibits Registration Chairman in the AFMS Uniform Rules Book).

- *Solicit suggestions for recommended rules changes from NFMS members, and in consultation with the other Committee Members prepare and present suggestions for changes in the Uniform Rules to the AFMS Rules Committee.
- *Represent the NFMS at the annual AFMS Rules Committee meeting or prepare an alternate. Compensation will be allowed at a mileage rate no greater than the current round trip economy air fare, or if direct air service is not available then by IRS mileage by the most direct, usually traveled route.
- *See that all materials pertinent to the competitive show are purchased and available for the annual show, e.g.:
 - (a) Award trophies and place ribbons.
 - (b) Judges & Exhibitors score cards should be sent to Exhibits Registrar Chair. Added word.
- (c) Rules Committee Chairman may be asked to purchase ribbons need by the Host Society, e.g. paid for by the Host Society "Host", "special Awards", and "Dealer", and paid for by the NFMS "Officer", "Past President", "Delegate", "exhibitor", "judge", and "clerk". (This is really confusing to me. The Host Society has been furnishing all of the badges for the show except for the Judgers Ribbons which is the responsibility of the Judging Committee. This line should read "should provide judge badges for all Judges and Clerks".)

 *See that members of the NEMS are kept aware of all current revisions and interpretations of the Uniform
- *See that members of the NFMS are kept aware of all current revisions and interpretations of the Uniform Rules. Add "see www.amfed.org for current AFMS Rules).
- *Be the final authority on interpretation and application of the Uniform Rules at the Annual Show except that those rules pertaining to judges and judging shall be the responsibility of the Judging Director.
- *Maintain records of all past winners and those who have gained eligibility for AFMS competition and see that the ASMS Rules Committee receives copies of this information.
- *Oversee the processing and recording of all score cards during the Judging, indicating place awards, division awards and those in contention for the sweepstakes, special and memorial awards.
- *Oversee the distribution of all place awards and awarding of trophies.
- *Provide a list of all winners to the Northwest Newsletter Editor for Publication.
- *Answer questions from the membership regarding nomenclature. Those questions that cannot be answered personally will be referred to the best authority available.

Add:

- *Make up Competitive Application (forms) for the applicable show and have them printed in the NFMS Newsletter.
- *Tell Host Society that the Judges need a room with two tables and chairs from start of set up time to close of the Awards Banquet.
- *Tell Host Society to provide at least three chairs for each Judging Team to use on the floor.

SECTION 2, JUDGING DIRECTOR

Judging Director shall:

- *Be responsible for obtaining and appointing sufficient judges and clerks to judge all classification of exhibits at the NFMS Annual Show.
- *Prepare judging teams of two (2) or more judges and one (1) or more clerks for NFMS judging. Three (3) member judging teams are mandatory for AFMS trophy judging. A separate judging team or teams may be required for special and memorial trophy awards.
- *If at all possible, only one team should judge the cases competing for single division award except in divisions where mixed exhibits are allowed. If this is completely impractical it will be necessary to form a composite team of those involved to re-evaluate the place winners to determine a division winner. This is necessary since each team will judge at a different level and the highest score may not represent the highest quality. Select a composite team with representation from each competitive field to re-evaluate all the blue ribbon winners for election of a sweepstakes winner. This will have to be done for General, Society, and Junior exhibits.

- *See that all material pertinent to judging is obtained and made available e.g. judging forms , 10 X Loupe (microscopes are not allowed anymore), faceting inventories, carrying boxes for faceted stones and micro-mounts, references, rules, etc.
- *Prepare judging teams to do their work. See that they (change to Judges) are made aware of interpretations that have been made and (add) are using up to date rules and revisions.
- *Supervise the judging procedure, making certain that the Uniform Rules are being properly administered as well as the NFMS Supplementary Rules. Delete
- *Be prepared to make any decisions concerning judging procedures on the floor, however any rules interpretations should be referred to the Rules Chairman for final decision.

SECTION 3, EXHIBITS REGISTRAR

Exhibits Registrar shall:

- *Be in charge of receiving applications for Competitive display space for the NFMS Show and AFMS Show when hosted by the NFMS.
- *Work closely with the Display Chairman of the Host Society in planning display arrangement. (Host Society should make this person a member of the Society to comply with AFMS Uniform Rules). (Delete, replace with "and notify Display Chair at least three weeks before the show as to how many Competitive cases there are.")
- *Keep records of all application, checking eligibility of exhibitor to compete in indicated group and Class.
- *Keep the Judging Director and Rules Chairman closely posted as to number of exhibitor in each class.
- *Work with the Host Display Chairman using their general plan to display area to make specific space assignments for competitive displays, keeping in mind convenience for judging teams. (Remove, see above).
- *Prepare a list of non-competitive exhibits for Host Display Chairman who will make these space assignments. (Remove sentence. Host Society is in charge of non-competitive and special displays).
- *Be available during show set-up with sufficient help to assist incoming exhibitors to their proper location and see that the case is properly identified for judges.
- *Supply exhibitor with exhibitor ribbons. (Delete sentence. Ribbons mentioned above.)
- *Prepare a exhibitor card for each competitive display entry and a judges score card for each class for which you have an entry. This should be done prior to the show and be available for the judging Director prior to judging time.
- *Provide application forms, request and status reports for publication in the Northwest Newsletter.
