NFMS Safety Chair Articles - Kathryn Larson:

It's wintertime and it's cold out there. Brrrrrrrr! When the wind starts blowing it becomes even colder. The other day it felt like the wind was blowing directly off a mountain of snow. And as we age our bodies lose heat more quickly than they used to.

When you go outside, wear multiple loose layers of clothing. Wear hats, gloves, warm socks. I usually stay warm, but I really like wearing gloves. I try to keep a pair in my coat pockets. I also try to remember to wear sturdy slip-resistant boots or shoes for traction. It's very easy to slip when everything gets coated with ice. Landing hard on a sheet of ice is a good way to break a bone.

Limit your exposure outside when it's really cold and drink plenty of liquids. We may not feel thirsty, but we still need to drink water. I like drinking hot water with slices of lemon. It's refreshing and not loaded with sugar or caffeine. Even though we're stuck inside we still need to stretch occasionally and move around. And remember to check on your neighbors, especially the older ones.

Hang in there. Spring is coming.

EYE SAFETY

Most of us work around rocks daily. Our eyes are a valuable commodity. We use them to spot flaws in our stones, look for scratches in our cabochons and enjoy the beauty of our rocks. Over 125,000 eye injuries occur every year. Up to 20% of these injuries cause temporary or permanent vision loss.

When you are out in the field digging, hammering or chiseling rocks, use safety glasses to protect your eyes from flying chips. Air-blown dust and sand can get into your eyes and causes scratches on the outermost layer of your eye, the cornea. Wear goggles while working in the shop grinding, sanding or polishing stones. Wear your safety goggles anywhere there is a chance of flying pieces. Wildfire smoke can cause red, burning, itchy eyes. Keep eye drops on hand to wash out any debris. Be careful of others around you watching you work.

If any injuries occur, contact your doctor for advice. The doctor may suggest flushing your eye with sterile water before coming to see him.

You only have one set of eyes. Protect them.

Remember, you can also enter your newsletter as an item for the contest. I know all the information can be a bit overwhelming but just reach out to someone for help. Treasures of the Northwest

Hello from the mountains of Montana and welcome to the Hellgate Mineral Society (HMS) Annual Gem and Mineral Show, the ***Treasures of the Northwest***, and the 2026 Northwest Federation of Mineralogical Societies (NFMS) Convention. The show is set for Saturday and Sunday, March 21-22, 2026.

The show is being held at the Hilton Garden Inn, 3720 N Reserve St, Missoula, MT 59808, Phone (406) 532-5300. The Hilton Garden has set aside ten rooms for NFMS members and vendors on a first come, first served basis.

Daily admission is \$5.00 per person, with children under 12 free when accompanied by a paying adult. The show will be offering exhibitions on wire wrapping, flint knapping, silver smithing, gold panning, and fossil prepping. Fun activities include raffles for rock-hounding paraphernalia, hourly door prizes of vendor-donated gems and minerals, the sale of grab bags of rock and mineral specimens, a silent auction, and a Spin-to-Win. Fun activities for the younger crowd include a mineral dig, geode cracking and a kids-only silent auction.

As the show is in March, and the show is in Missoula, the ability to have field trips is sharply curtailed. So, new this year, we are offering the opportunity participate in “onsite field trips” where attendees can sift for sapphires, sift for garnets, sift for sunstones, and pan for gold.

The HMS show is hosting eighteen vendors. There are also three club tables with six club members (three on Saturday and three on Sunday) displaying and selling their wares.




