Endowment Fund Committee Meeting Friday, May 19th 11:00 am

The Northwest Federation of Mineralogical Societies Endowment Fund Committee will be discussing some possible amendments and changes to its Operating Procedures at the Annual Meeting in Hamilton. Before these proposals are finalized for a vote by the delegates, the committee seeks input from member societies and will be holding an open meeting where delegates can help formalize the propose changes.

This open committee meeting will be held at the Townhouse Inn, in Hamilton starting at 11:00 am on Friday, May 19th. (Note... This is not the same hotel where the annual meeting will be held.)

Items to discuss include:

Should we modifying the definition of unrestricted funds (these are the funds available to expend annually) to allow the funds to be accumulated over multiple years before expenditure.

Raising the minimum balance maintained in the Restricted Fund account. (These are the funds that make up the permanent endowment fund which generates the income that can be expended annually.)

Determine how much we want to spend annually from the endowment fund.

Restrictions on use of endowment fund monies.

Procedures for soliciting and awarding grants funded through the endowment fund including criteria to use when prioritizing requests for use of endowment fund monies.



I would like to thank all of you for taking action concerning BLM's actions concerning rockhounding in the sage grouse areas. We are at a point now where the only way to maintain the use of tools for recreational rockhounding is to have our Congressional Representatives get involved. Two bills have been introduced in the House and Senate but have not been moved out of committee. We need to get our Representatives and Senators to support Rep. Rob Bishop's and Sen James Risch's bills that will delay sage grouse land withdrawal and provide for state and local input into sage grouse protection. If the bills are not passed into law before September 2017 then the restriction on the use of tools for rockhounding will become final. Please take the time to contact your Representatives and Senators let them know you support these bill.

H.R.527 — 115th Congress (2017-2018)

Rep. Bishop, Rob [R-UT-1] (Introduced 01/13/2017)

Greater Sage Grouse Protection and Recovery Act of 2017

Summary:

This bill addresses the Department of the Interior's October 2, 2015, finding that the greater sage grouse is not an endangered or threatened species. Until September 30, 2027, Interior may not alter or invalidate the finding.

Additionally, Interior and the Department of Agriculture (USDA) are prohibited from amending any federal resource management plans that affect the greater sage grouse in a state in which the governor has notified Interior or USDA that a state management plan is in place.

S.273 - Greater Sage-Grouse Protection and Recovery Act of 2017

Sen. Risch, James E. [R-ID] (Introduced 02/01/2017)

SEC. 4. PROTECTION AND RECOVERY OF GREATER SAGE-GROUSE.

- (a) Endangered Species Act Of 1973 Findings.—
- (1) DELAY REQUIRED.—The Secretary of the Interior may not modify or invalidate the finding of the Director of the United States Fish and Wildlife Service announced in the proposed rule entitled "Endangered and Threatened Wildlife and Plants; 12-Month Finding on a Petition to List Greater Sage-Grouse (Centrocercus urophasianus) as an Endangered or Threatened Species" (80 Fed. Reg. 59858 (October 2, 2015)) during the period beginning on the date of enactment of this Act and ending on September 30, 2027.
- (2) EFFECT ON OTHER LAWS.—The delay required under paragraph (1) is and shall remain effective without regard to any other statute, regulation, court order, legal settlement, or any other provision of law or in equity.
- (3) EFFECT ON CONSERVATION STATUS.—The conservation status of the greater sage-grouse shall be considered not to warrant listing of the greater sage-grouse as an endangered species or threatened species under the Endangered Species Act of 1973 (16 U.S.C. 1531 et seq.) during the period beginning on the date of enactment of this Act and ending on September 30, 2027.

(Some of the following information is taken from an article on KSL.com by Amy Joi O'Donoghue, March 26, 2017)

Safety tips for people to follow are talked about, discussed and even published. Some people are trained to take care of most dangers that are encountered while hiking, camping and, yes, even rock hunting. One danger that I have never seen on a list of safety tips out there is, "In some areas where Rock Hounds are, is a "cyanide bomb", which is EXTREMELY LETHAL! .

The name of these bombs is M-44, which has been used for predator control on small animals (Sheep). M-44's have been used for many years, since about the 1930's and 1940's. These devices are placed on the land by Wild Life Services, a branch of the Federal Government. The bottom line become familiar with, and know what the M-44 device looks like. Instruct your family and friends to LEAVE THEM UNDISTURBED! DO NOT touch them - and, keep your dog and children away from them! When the M-44 Device is in place, there is supposed to be a Community Notification and their location should be CLEARLY MARKED, (not always done!) The M-44 Device is used in about 16 States around the country, mostly in the west. The use of these devices apparently varies from state to state. Be sure to check out what this lethal device looks like. Go to Goggle on your computer and type in "What does a cyanide bomb look like?". This site will also show different types of cyanide bombs. If you encounter one treat it like a live bomb! That is exactly what it is! Be safe in all you do!



COST FOR "RETREAT" REGISTRATION

Registration - Cost includes Breakfast and Evening Dinner with a Sack Lunch, sleeping quarters in an A-frame cabin, (Bring your own bedding and pillow -- mattress provided), or dry camping for an RV. No hookups available. **If electric hookups are needed, they will cost \$15.00 for the week.** Tenting is the same price as RV or A-frame cabin.

6 Day Total = \$282.00 +\$15.00 for RV Electric plus Workshop fee of \$45.00 Meals furnished.

If you can't stay the full time we can break it down by the day. This would mean \$57.00 per day, plus the Workshop Fee to take advantage of this great program.

Trip to Fossil Bed and Museum – Trip will be in Vans.

Cost will be \$35.00 per person. This will be a full day trip away fron the Retreat. We need at least 10 to make this trip a go. You will get a tour of the Fossil Beds, see the country and visit the new museum.

Workshop Cost: \$45.00 for Workshop (One fee covers all)— Choose Primary and Secondaries.

Silversmithing - Fee per project to instructor. Provide your own stones if you want. <u>All Participants</u>

<u>must provide eye wear for safety purposes.</u>

Virewranning — Bring your own wire or buy from instructo

Wirewrapping – Bring your own wire or buy from instructor. Provide your own stones or purchase from instructor. If you have your own tools, please bring them. We will have some available.

Intarsia – Per Project cost provides full kit with materials from instructor.

Beading – Components and kits can be purchased from instructor.

Casting – Covering multiple casting methods and building wax models. Check new agenda for 2016.

All Participants must provide eye wear for safety purposes.

Jewelry Carving- A \$50.00 fee per person (To Instructor, first day) to cover Equipment and Diamond use).

When moving to a new Workshop, confirm with new instructor for available space.

We must have a minimum of 25 people register to make it all happen, with a maximum of 53 participants. Please send registration in as soon as possible because we must let the camp know by June if we have enough to go. Help us keep this great activity going. Registration is first come, first served.

The "Swap Session" is a place to swap materials, arts, crafts, rocks or anything that someone else might want. No money will change hands, just goods.

NOTICE

Due to the fact that this property is in the middle of a National Monument, we are subject to much closer scrutiny than other properties. We have gone through a lengthy process and here are the parameters that we will work with . Our group is the only one that is allowed to bring RV's on the property so we have a privilege no others can get.

NO PETS. Exceptions will be made for service animals, but they must be registered with me 45 days prior to the event so that I can notify the camp Manager within 30 days. No animal waste may be left on the OMSI or NPS property. Animals may not be allowed to run loose.

Smoking is prohibited. If a group participant chooses to smoke they need to first check in with the Manager to find a designated space, and the smoker is responsible for cleaning up and packing out all cigarette butts.

Alcohol. Alcohol is permitted, but must be consumed in moderation and under control. Guests must dispose of all alcohol containers offsite from Hancock Field Station.

Earliest arrival time is 3pm. Hancock Field Station staff are cleaning and preparing the site from the previous group and are not able to accommodate early arrivals. Because of this, group participants arriving before 3pm will be asked to leave and come back at the appropriate time.

Parking. Parking is allowed in designated areas only. The camp manager is responsible for all parking management and any issues or concerns that arise. Group participants must follow the direction and decisions of the camp manager. There is no parking or waiting allowed on the National Park Service Road that connects Hwy. 218 to the Hancock Field Station. There is also no parking or waiting on the Hancock Driveway which is also a designated fire lane. These roadways are required by State and Federal guidelines to remain open to allow emergency vehicles access to Hancock Field Station. Once at Hancock guests are not allowed to drive over drainage ditches in order to park a vehicle on the other side.

Housing and RV's. OMSI will provide privacy curtains for use in the larger A-frame cabins upon request. There is a maximum of 10 partial hookups for RV's. Six will be used by instructors leaving only 4 RV hookups for use by participants, and those must be under 26 feet in length. NOTE – No AIR CONDITIONERS allowed to run. This means that if you plan on bringing an RV, the first four RV's under 26 feet will be allowed. All others will be assigned cabins for the program.
