From the PRESIDENT's Desk...

2020 NFMS/GOLDEN SPIKE SHOW & CONVENTION CANCELED

As a result of the Utah Governor's statewide Coronavirus Emergency Declaration on March 12th, 2020, and his recommended restrictions on assembly of persons over 60 years of age at Utah-based events of more than 20 people in size, the Golden Spike Gem and Mineral Society President Mike Rhodes regretfully announced on March 16th that its Club show April 9 - 12, 2020, in Ogden, Utah,

was being cancelled. As a result, our NFMS Convention/Meetings and associated AFMS Judges Training sessions and ALAA Instructional meeting — that were scheduled to be conducted in conjunction with that show — must also be cancelled. Those planning to conduct or receive Judge training have been or are being notified separately by AFMS, and ALAA will publish the cancellation of its meeting through additional channels as well. Announcement of these cancellations will also be posted on the NFMS website even before you will receive this Newsletter through the USPS mail.

As expected after the Utah Governor's announcements, there has been a flurry of cancellations and postponements of events in Utah, and there are many NFMS Club-level shows in other states set for conduct over the next several months throughout the Northwest that are being cancelled or postponed. Though understandable given the potential vulnerability of those over 60 (and especially over 80), this is, nonetheless, truly a disaster

for our recreational rockhound community, as these venues are major fundraisers for most of our NFMS clubs as non-profits. I ask that all members re-double your efforts to support Club activities and consider innovative fundraising activities this year to blunt the effects of these widespread cancellations. If you can reach out a helping hand to Federation Clubs that have had to cancel shows (watch the Federation website), PLEASE do so. The many cancellations will be disastrous, too, for our dedicated small-business dealers who are really "family" to our many clubs. Treat them as family and try to find ways to support them and reduce their costs at remaining shows -- and between shows.

We will be trying now to plan a separate, follow-on, more bare-boned NFMS meeting to accomplish Officer elections and other required annual business for scheduling, tentatively, between late Summer and early Fall, assuming that the major impact of the virus' 2020 cycle will have largely slowed or passed, and most of life's normal activities will have been resumed. Watch this Newsletter and the NFMS website for emerging details.

I thank the Golden Spike Club for its great work already done to prepare for both its always-spectacular show and our NFMS/AFMS activities, and especially the effort of youngster Evan Day for his show-planning leadership and for keeping me apprised of the Utah coronavirus situation and the consideration process that was undertaken by the Ogden-based Club as it reached this difficult decision.

Fortunate is the person with a hobby, especially one which is both practical as well as interesting. Everyone should have two occupations from a standpoint of economic

security if for no other reason. Your occupation or your job may be secure today, but who can see into the future?

Changing economic conditions, accident, or loss of health may be one of the numerous reasons which may force an individual to change in occupation. How often have we seen a hobby become a lucrative vocation for an individual forced to make a change. The one-job man is at a distinct disadvantage in our complicated system of civilization. Provide yourself with a by-pass should your main economic highway be blocked.

Some activity in the earth sciences as a hobby will do much to add to your general happiness, and perchance someday it may real-

ly prove valuable. Few persons take up a hobby with the idea of it becoming a regular occupation, but in times of stress, or some unforeseen accident, a hobby may prove invaluable.

If history repeats itself, it will later be shown that investments made in fine mineral specimens, and choice cut gems, in times of affluence will prove a boon in times of financial stress. Consider the money spent on fine minerals, as an investment, they are not a “luxury”. We know too well the history of many “gilt edge” bonds, and security considered as sound. In September the Annual Rockhound Retreat will be held at OMSI – Camp Hancock. Classes will be held in Silversmithing, Metal Working, Enameling, Intarsia, Carving, Beading and Wire Wrapping. Several evening programs will be held including Stump the Experts, Swap Meet, Auction and cooking smores. This year’s camp will be on September 7-13, 2020. Hope to see you there.

Notice

The Northwest Rockhound Retreat Chair shall have the right, at his/her sole discretion to expel from the Retreat, Retreat participant(s), who’s actions in his/her opinion is objectionable under current community standards, or has or is suspected of breaking any laws of the State of Oregon, or against the rules of the Retreat. The Northwest Rockhound Retreat chair shall not be held liable for his/her action taken and no re-funds will be made.

Due to the fact that this property is in the middle of a National Monument, we are subject to much closer scrutiny than other properties. We have gone through a lengthy process and here are the parameters that we will work with. Our group is the only one that is allowed to bring RV’s on the property we have a privilege no others get.

This means that if you plan on bringing an RV, the first four (4) under 26 feet will be allowed. All others will be assigned cabins for the program.

NO PETS. Exceptions will be made for Service Animals, but they must be registered with me 45 days prior to the event so I can notify the Camp Manager within 30 days. No animal waste may be left on Camp Hancock or National Park Service property.

SMOKING is PROHIBITED. If a participant chooses to smoke they must first check in with the Camp Manager to find the designated space, and the smoker is responsible for cleaning up and packing out all cigarette butts.

ALCOHOL. Alcohol is permitted. It must be consumed in moderation and under control. Guests must dispose of all alcohol containers offsite from Hancock Field Station.

EARLIEST ARRIVAL TIME IS 3 PM. Hancock Field Station staff are cleaning and preparing the site from the previous group and are not able to accommodate early arrivals. Because of this, NWRR participants arriving before 3 PM will be required to leave and come back after 3 PM.

PARKING. Parking is allowed in designated areas only. The Camp Manager is responsible for all parking management and any issues or concerns that arise. Group participants must follow the directions and decisions of the Camp Manager. There is no parking or waiting on the National Park Service Road that connects HWY 218 to the Hancock Field Station. There is also no parking or waiting on the Hancock Driveway which is a Designated Fire Lane. These roadways are required by State and Federal Guidelines to allow emergency vehicles access to Hancock Field Station. Once at Hancock Field Station group participants are NOT ALLOWED to drive over drainage ditches in order to park a vehicle on the other side.

HOUSING AND RV’S. Camp Hancock will provide privacy curtains for use in the larger A-Frame cabins upon request. There is a maximum of 10 Electric hookups for RV’s. Six will be used by instructors, leaving only 4 RV Hookups for use by Group Participants, and those must be under 26 feet in length. Generators are not allowed to be run at Hancock Field Station.

NO AIR CONDITIONERS. NO RV or personal air conditioners can be used at Hancock Field Station.

- We are surrounded by the John Day Fossil Beds National Monument.** The removal, possession, or disturbance of any fossil, mineral, plant, archeological object, or any other natural or cultural feature is prohibited. If you go hiking stick to the trails and leave what you find.
- Keep food safe from rodents.** Store food in refrigerators, coolers, or cars; not in cabins. Put all food waste into designated bins not with other trash.
- Use the recycling bins and trash cans** located on the side of Berrie Hall. Separate food waste from other trash or recycling.
- Arrive promptly for meals.** Food is hot and fresh at the time meals are listed. We will blow the Conch Shell to let you know that a meal is about to start.
- Feel free to use our extra water bottles (under the KP Station.** Return used water bottles to the KP Station to be washed. Also feel free to use the sunscreen (above the trail map on the side of Berrie Hall).
- Walk or Skip** when traveling around camp. It's easy to slip when running in gravel. Carry a headlamp or flashlight when it is dark.
- Travel on surfaces with gravel or cement.** Avoid walking in or through drainages and stay off hillsides.
- Let someone know if you are hurt or ill.** The Camp Manager, Assistant Manager, and Northwest Rockhound Retreat Chair are available at all hours. The Camp Manager lives in the Managers House, the Assistant Manager lives in the rectangular cabin in lower camp.
- If you go hiking, tell someone** where you are going and when you expect to be back. Trail maps of the Clarno Unit are available to borrow – please ask a manager.
- Please respect the wildlife** that lives in and around Hancock Field Station. Do not catch or chase around camp or the National Monument.
- When viewing the owl** please stand back from the bars. Do not put fingers or hands into the enclosure, Groups should be small and remain quiet. The owl is wild.
- The use of alcohol, tobacco, and marijuana are prohibited on the National Monument.**
- Smoking and vaping** are only permitted in designated areas of Hancock Field Station. Please ask a manager where you may smoke or vape. Fully extinguish cigarettes. The use of marijuana is prohibited at Hancock Field Station.
- If you choose to drink alcohol, please drink responsibly.** We are an hour away from a hospital. You must pack out any drinks, bottles, or other containers uoy bring with you.

Important BLM Information for All Federations

In December my husband and I along with the corgis moved from California to Oregon. I am grateful for the many years of enduring friendships and the experience working with the California and Nevada rock and gem societies. Although I haven't been in the state for a full month as I write this and am still busy going through mountains of moving boxes, I have been get-ting familiar with some aspects of the Oregon BLM. For societies within states which have BLM offices, there is a good website for finding all of BLM's Resource Advisory Councils (RACs) near you: <https://www.blm.gov/get-involved/resource-advisory-council>. These councils really need your involvement as Recreational Rockhounds to show up for the meetings and to apply to be on the committees when there are vacancies. Without your input about the value of our unique historical American recreation when it's needed to protect your collecting sites and educational field trips areas, the councils can't forward your insight and information to the BLM who will in turn use that information in the various stages of developing their plan-ning. Below is the Oregon BLM boundary map for all the state's current RACs: https://www.blm.gov/sites/blm.gov/files/getinv_rac_orwa_racboundarymap.pdf

Below is the website for the Federal Register, which is the daily journal of the United States government. It is easy to use their Search engine to find out the latest on RAC meeting dates, etc., for your and other boundary areas around the country: <https://www.federalregister.gov/> Depending on the issues and who uses the public lands within your RAC boundary areas, members of the RAC usually/may include a variety of individuals involved with ranching, outdoor recreation, industry, state and local government, tribal lands, academia, conservation and environment. To give you an example of how diverse the members of RAC's can be, the Desert Advisory Council (DAC) which is a RAC in California, has a member representing the film industry's access to the desert. Another member of the DAC is a lifelong resident with a family history of living in the area for many generations, who saw the increasing lack of freedom in recreational use in the desert since his youth and wanted to get involved to help keep access open for the public. I hope these examples show you, that you don't need to be a rocket scientist to be on these councils. Recreational Rockhounds have a place on the councils, and by attending the meetings or being on a RAC, you will be an immense help.

Council members serve three-year terms on a staggered basis. This means that one-third of the council is subject to appointment or reap-

pointment each year. These Advisory Council meetings are open to the public and meetings are announced in the Federal Register and through news releases. The Dept of the Interior has been actively promoting recreational activities on public lands through news releases since last year, so this is an opportune time for your societies to jump in if you haven't before and become involved and make some friends at BLM. Good ongoing relationship with the BLM is now a necessity, because what happens to one state's recreational rockhounding area(s) affects all of Recreational Rockhounding, and what will become of our hobby as an American historical recreation in the future.

New~ ALAA Recommendation to All AFMS Federations & Your Societies

We are encouraging you to work closely with your societies to create a display case of the rocks, gems, minerals, and fossils of the closed collecting sites in your territory due to public lands regulation, and to display the case(s) at your annual shows and conventions, and at the local society shows whenever possible. If every federation would show a representation of this, it will make a big impression on your members to become more collectively involved in protecting your current field trip areas now and for the future. Take photos of the material along with identifying it and note where the collecting site was. Include this information in your federation and society newsletter issues. ALAA would like to have this information for it's database, website and newsletters, and for articles in the AFMS newsletters. Let's get Rock'N on this project so we can keep on Rock'N our collecting sites.

THE BLM IS ON THE MOVE The Bureau of Land Management is moving its Washington, DC office to Grand Junction, Colorado. The exact time frame of the move is not known at this time. Check on the BLM Website for more information. This will make contacting the main BLM Office easier for the Recreational Rockhound. Another BLM move is the California Desert District office is moving from its Moreno Valley, CA location to a new office in Palm Springs, CA.NB: The BLM manages one in every 10 acres of land in the United States, and approximately 30 percent of the Nation's minerals. These lands and minerals are found in every state in the country and encompass forests, mountains, rangelands, arctic tundra, and deserts.
