

Public Review of Rockhound State Park Management Plan

It was standing room only at Rockhound State Park on Tuesday, March 29th. Folks started arriving at 5:00 for the meeting scheduled to start at 6:00. The purpose of the meeting was to allow the public to review and discuss the recent Rockhound State Park management plan, drafted by the NM State Park managers. It included a proposal to ban rockhounding within the State Park.

The following representatives attended from Santa Fe: John H Bemis, Cabinet Secretary (designate) for Energy, Minerals and Natural Resources; Tommy Mutz, State Park Director; Dave Gatterman, Park Projects; Christy Tafoya, Archeologist; Cynthia Lovely, Park Planner. Other State Park managers: Rolf Hechler, Region 3 superintendant; Robert V. Apodaca, Rockhound/Spring Canyon Park Superintendant. Special guests in attendance were: Representative Dona Irwin, Deming City Council; Linda Enis and David Sanchez; John Sutherland, Luna County Manager along with Mary Galbraith, Executive Director of the Chamber of Commerce; Linda Smrkosky, Economic Development; and Virginia Pool and Pat Guthrie, representatives of the Deming Luna County Museum.

Many members from the Deming community spoke about how much rockhounding has meant to them as well as the reason they settled in this area. Several out of state people in attendance commented that they spent \$2,000 and more per visit to this area.

Comments included limiting the area where rocks can be gathered; lowering the amount of rocks (currently 15 pounds) and setting limits like how much per person per day for those guests camping the 21 day limit.

Mr. Bemis & Mr. Mutz were very pleased with the turnout and quite impressed to see that folks did respond—they now understand that we DO read the management plans. It was my impression and other Friends members that the park will remain as always—no ban on rockhounding but perhaps some more clear delineations of where and how much

Mary Galbraith from the Chamber of Commerce had numbers of RV's and folks who came into the visitor center during Rockhound Roundup—the numbers were significant.

Thank you so much to all of you Friends who attended, e-mailed, faxed and wrote letters. We could not meet our mission of preserving, promoting and protecting without all of you!

One example of the outpouring of support was told to me by Linda Enis, City Councilwoman, who said she received 70 e-mails from all over the US in favor of Rockhound State.

Field Trip, Public Lands and the Annual Show

I would guess that by the time you have read this, the Hampton Butte fieldtrip will be history. It has been fun working with the USFS and the BLM setting this up. I think that working with instead of against will help keep our collecting sites open in the future.

As of 15 May we have over 250 collectors that have indicated they were going to attend this trip. With 6 trip leaders this should go smoothly and I would like to thank all of those who have stepped up to help with this event. I will give a full report on the trip in the next issue.

The article I wrote on the Public Lands and the permitting requirements has caused a number of different reactions, some saying that this was not true and I was just trying to stirrup or cause problems. Others called the BLM and received a number of different answers. My main source of the information came from the information distributed by the BLM, Billings, Montana office and the fact that every time I have gone to the BLM and talked about a Non-Profit fieldtrip, the first thing out of there mouths was, you will have to apply for a recreation permit, in Wyoming I was told that 20 or 100, I still needed a permit. Others have called their local offices and have been told that a permit was not needed. SO there are a number of interpretations throughout the west. I guess the best way to deal with this is simple, just call your local district and ask!!!

Our NFMS Show will soon be here and it's time to get involved, show the rest of the federation what you have to offer. There will be a live auction during this event and I would like to see everyone check out that shed or garage and donate some of that extra material you have been buying or collecting over the past years. You and I know that you will never cut or use it all! Donate it and ask that some of the monies be set aside to support our multi federation fieldtrips. The trip at Hampton Butte will have cost over \$500 when all is said and done. So step up and help us.

I have completed updating the mailing list from the rosters each club sent in with their federation dues. From the rosters the following changes were made: 966 additions;



813 deletions; 135 changes of address. In addition to those numbers I should include the changes made from the information I received directly from your clubs: additions 162, deletions 84; changes of address 16. In all, the federation grew this year! Congratulations!

Now, all who should shall receive a newsletter, and we will not spend money on sending newsletters to those people who no longer belong to the federation. The newsletter is our federation's biggest single budget item.

Jack Eads, our Web Master, has kindly offered to send an "Early Edition" notification to those people who wish to download the newsletter, instead of taking one of the valuable print editions. The Golden Spike club has ten members that now take the electronic version of the newsletter. We will soon have more signed up to do so. One reason is that they won't have to go to the web site and download it. I will do that for them and send it to them as attachments to their e-mail. I will only do this for my club.

If you think keeping track of physical addresses is complicated, try keeping track of more than FOUR THOUSAND e-mail addresses. But, perhaps someone in your club might be able to offer this incentive to your club members.

I am amazed, and proud, that the NFMS sends a newsletter to each and every member of the federation. But we should strive to keep this 'increasing' cost, as minimal as we can. As of right now there are only 13 members of this federation who have let me know that they no longer want a print newsletter sent to their homes.
