
### NFMS NEWSLETTER AND WEBSITE <u>ADVERTISEMENT</u>

"Brings Stability"

One of the most important functions of a club when planning their annual show is how to pull off a great Silent Auction. The auctions are one of the most enjoyable show activities for visitors who are relatively new to the hobby – especially those who have children with them. Kids often see "spectacular" in material that "veterans" see as

"been-there-and-done-that-and-I-have-a-better-piece-already-or-can-go-get-it-myself." On the other hand, seasoned collectors And gray-beards (especially those from other clubs who may be visiting) L-O-V-E to check out the auction offerings; they Usually make a quick decision on whether the silent auction is a "go-to" spot or not worth the effort to keep checking during their "day-at-the-show." The trick is to satisfy all the groups that attend the show, make it a fun experience, --- and --- make some money for the club!

There are lots of different ways to do that, as I've been noticing when visiting shows these past four decades or so (yes, I'm old) and being refreshed in my recollections as I attended eight shows in the last three months. Some are worth mentioning, I think.

**Material:** Most auctions offer donated "average or sub-par" material from local or regional spots or from donated collections by older members. A great source, to be sure, without doing a lot of work months in advance. It still takes effort, however, to sort, select, clean, and segregate those materials just before the show so you are efficient in re-stocking the "offering plates" every 15 minutes or so during the show days. The better auctions seem to always have a "hovering" crowd all day since a mixture of reasonable materials are offered: (1) Along with average materials, there are at least one or two nicer pieces with a reasonable "minimum starting bid prices" clearly marked on the bid sheet. Seasoned bidders (including your own club members [and spouses/helpers of your vendors, too]) who may want the piece will notice that the auctions need to be checked often so as not to miss a real bargain. (2) Hobby-related books, pamphlets, maps, and high-end journals/magazines also sell well and are treasured by the veteran members if they can see future "field collecting trip spots" as a potential payoff. (3) If you do a lot of really unique Local stuff available, don't just put great pieces out without an appropriate minimum opening bid being set; the supply of that material will dwindle over time – especially if it is no longer collectable. (4) The better auctions also often have good-quality used lapidary-related or field-trip equipment, larger nice specimens, or high-end donated items set aside on one end of the table as silent auctions that close mid-day or early afternoon (so attendees stick around a bit) – or close next day so as to attract bids from returning attendees and club members. (5) If you host a Northwest Federation Show in conjunction with your own annual show (a GREAT option, by the way), specifically seek out and encourage visiting NFMS delegates, attendees, and officers to bring materials from their local areas to donate for your auction. What may be common to them is often unique to your local members. Be sure you have them tell you what the material is called (especially for agate and jasper varieties). (6) "Glitter" and "color" attract the kids and give them a great sense of accomplishment when they successfully win a piece they can display with pride. Treat them right, but tactfully teach them how to bid properly too. (7) A stack of donated journals/magazines (Lap Journal, Rock and Gem, etc.) for purchase at a minimum cost (not an auction) is also a common attractant and an invitation to auction veterans to bid on other items while browsing.

Execution/Operation: (1) The best-run auctions have a way to assure that the opening and closing of the individual auctions are announced clearly throughout the day – usually at about 15-minute intervals, although some clubs vary on the interval times. I've seen a lighted neon-type sign mounted high on a venue wall that announces the remaining auction time, heard loud cowbells or voices over loud-speaker-system announcements of bid openings for the next round of bidding, or approximate bid-closing times. The announcers at the best auctions have a clear, understandable speaking voice and can be heard throughout the venue, often adding "color" about specific, more unique items up for bid during that bid period. Here, I offer some cautions, too. At many shows, the "announcer" is whoever in the club is available, or one who "has done it for years because no one else will do it, or feels that "that's my job at the show." Sometimes this is GREAT for the success of the auction when that person is well-spoken, knowledgeable, and up-beat, but often it is a Continued on page 4

"Creativity & Compassion"

We all find ourselves responsible for many things in our lives: to put away our toys as children, to study in school, to get a job (and to do it well), to our families and to our friends. This all leads up to a responsibility that each member club in the NFMS has: to keep the NFMS up to date on their membership.

The NFMS often gets complaints from members that they are not receiving their NFMS Newsletter, sometimes for months at a time. Our Circulation person updates our membership list before each issue to make sure it is current before the NFMS newsletter is sent to the printer for printing and addressing.

But to make sure that the NFMS list **IS** up to date means that whoever it is in each club that is responsible for their club membership list needs to be pro-active in keeping Circulation informed of your club membership changes on a regular basis.

I want to give you an example. When our club prepares its roster at the beginning of the year, the member list with addresses, etc. is sent to the NFMS Circulation. But membership can change every month as new members are added to your club. The NFMS does not want those people to have to wait until the next year before they begin to get their NFMS newsletter. Our club, also, updates the Circulation with these changes each month. Then the members' subscription can start with the very next edition.

Another situation is that the NFMS puts out a directory of all the members once a year. Each club gets a copy and additional copies can be purchased for \$10. We want this directory to be as complete as possible too. When you send your membership list to the Circulation Chair, just add another person to your email, the Directory Chair.

DISASTER if so soft-spoken and "laid back" that their announcements can't be heard or understood clearly. Show Chairs I've talked to generally either ACTUALLY carefully select who announces and also checks speaking voice clarity in several parts of the building, adjusting as needed, or just "leave-it-to-Joe, as-he's-done-it-forever," regardless of how it sounds or later turns out as to financial success or attendee/dealer feedback. Show leadership Chairs need to think about that one, and figure out how to approach that "announcement" function to have the best outcome but not "ruffle feathers" unnecessarily within your volunteer group. Nurture the good ones.

- (2) The most successful auctions also tend to have enough helpers and a fairly knowledgeable local-material or general-mineral "expert" to efficiently prepare samples and bid-sheets (including minimum-bid prices) for the next auction to save on prep-time delays. This seems to also assure that those who are paying for their winnings get to see what is coming up on the next round of items for bid subtle but good advertising that assures interest or not depending on the offerings.
- (3) Substituting announcers or auction staff during the day is necessary, but also needs to be done carefully so that the money-box stays secured and set-up efficiency isn't compromised.

Bottom Line: Successfully organized and executed silent auctions with reasonable material and variety seem to consistently show MUCH better financial results than "ho-hum" auctions. As they say in one insurance company ad on TV: "What's in your wallet?" as far as your silent auction function is concerned? Good luck — and consider visiting other shows to mentally compare notes; when you see a well-run auction, possibly also speak with staff volunteers or their Show Chairs on "lessons-learned," and on how well they do financially on their auction function.

The description from the Operating Procedures of the NFMS and the information following explaining the AFMS Scholarship Foundation best tell the story of how this committee functions. Keep in mind that the end result of donations to this fund is financial assistance to students in a field of study relevant to the rockhounding hobby. Mary Lou Northrup is our NFMS Chairperson.



SCHOLARSHIP shall: \*Accept and acknowledge donations and maintain records of all contributions to the AFMS Scholarship Foundation made by Societies or individuals of the NFMS. These contributions, with any change in percentage standing, are to be forwarded promptly to the NFMS Treasurer. \*Publicize the work of the Foundation through the Northwest Newsletter and at the Annual Meeting. \* Report annually to the AFMS Audit Committee all donations received and forwarded. (Amended 7/19/2002)



### **AFMS Scholarship Foundation - A Resume to Refresh Our Memories**

The establishment of the Scholarship foundation was authorized by the addition of an Article to the By-Laws of the American Federation of Mineralogical Societies in 1958. The AFMS Scholarship Foundation, Inc. was set up as a separate corporation with its own officers and directors.

**Organization:** The Foundation was incorporated as the AFMS SCHOLARSHIP FOUNDATION, INC., a Minnesota Corporation on March 18, 1964. A Tax Exemption Certificate was obtained from the Internal Revenue Service on November 6, 1964.

The Board of Directors consists of: The President of the AFMS who is automatically both the Vice-President and a Director of the Foundation. The other Directors are: the AFMS President-Elect, and the President and the Vice-President of each of the six participating Regional Federations. The Board of Directors has the management of the Foundation.

The Board elects a President, a Treasurer, and a Secretary, each for two-year terms, the President being elected one year, the Treasurer and Secretary being elected the next year, to insure continuity of experienced management. It will be seen that the Foundation, while an independent Corporation, is entirely in the control of AFMS Federation personnel.

**Purpose of the Foundation:** The object of the Foundation is to accumulate a Fund, using only the income from the Fund to be used to finance Scholarships. The principal cannot be used for any purpose whatever, hence the usefulness of the Fund is perpetual.

**Awards to Beneficiary Students:** Beginning in 1965, one student received a scholarship grant of \$300.00 per year for two years to help achieve an advanced degree in any of the Earth Sciences. In 1966, the grant was increased to \$400.00 per year for two years; in 1967, the grant was increased to \$500.00 per year for two years.

As the Fund, and hence the income from it, increased, the grants were increased and, subsequently, more students received scholarship grants. By 1972, each Regional Federation received one grant of \$750.00 per year for two years. Grants were increased to \$1,000.00 per year in 1976; to two scholarship grants per each Regional Federation in 1981. In 1983, each grant was increased to \$1,500.00 per year for two years; and the amount was increased to \$2,000.00 per year for each grant in 1988. In 2009-2010 additional funds were raised to allow the educational grants to increase to a single \$4,000 educational grant starting with 12 students selected in the 2009-10 school year.

Grants are restricted to Graduate students to avoid the possible waste of money on students who are not committed to Earth Science subjects, or who drop out before graduation (Any student working toward an advanced degree is presumed to have definitely decided to follow that field for his/her lifetime vocation, insofar as such decision is possible). Since our joint interests lie in that field, grants are restricted to Earth Science students who are U.S. Citizens.

Selection of Beneficiary Students: Until 1972, one person of prominence in the Earth Science field was selected from among twelve nominees, 2 from each Regional Federation. That person, normally associated with a prominent University or College, selected the schools., and the students who received the grants. Since 1972, each participating Regional Federation has selected their own Honorary Award Winner who then selected the school(s) and assisted with the selection of the student, or students, who then received the scholarship grant(s).

This indirect method has served our purpose perfectly in that it benefits needy students, yet avoids the enormous task and expense of receiving, sifting through and evaluating applications from hundreds of applicants, which would otherwise be necessary if selections were made by ourselves in the conventional manner.

**The Fund**: In the beginning, Betty Crocker coupons were accepted and turned in to General Mills at  $1/2\phi$  per point until December 31, 1974., when the program was discontinued by General Mills. Coupons accounted for approximately 10% of the Fund at that time. Since that time, the trust fund has been supported by donations and memorials from "rockhounds", nationwide. The market value of the investments of the Foundation, as of October 31, 2010, stood at just over \$1,024,170.00. With the exception of a few hundred dollars received from outside organizations, the entire amount has been donated, by Earth Science Clubs and Societies throughout the entire nation, and by individual members of such groups.

**Gifts:** All gifts to the AFMS Scholarship Foundation are held to be tax-deductible to the donor, and are normally added to the "trust" account. Gifts should be sent to each Regional Federation's Scholarship Chairman, who will see that the donor receives proper credit, and will forward the gifts to the proper Foundation Officer. Founder's Certificates are issued to individuals, dealers, or firms that contribute \$500.00 or more to the Fund, either as one gift or cumulatively, but the individual's club does not receive credit for such gifts.

Gifts may be made directly to the "Unrestricted Fund" by marking "Unrestricted" on the donation check or in a letter accompanying the donation. Unrestricted funds are not automatically put in to the investment account and may be directly paid out as



(Continued from page 5) educational grants to students instead of using the investment income only from the trust (investment) account, for the educational grants.

Goals for the Future: Our first goal was to establish a Fund of \$50,000.00 which would provide an annual scholarship in Earth Science. This goal was reached in 1968. Having attained that goal, do we stop when such attractive vistas and horizons appeared? By no means!

The Fund has now achieved over twenty times it first goal and we are providing a single year scholarship grant of \$4,000.00 each year to two students selected by each of the six participating Regional Federations. What do we see ahead? Wonderful additional opportunities for service and help for more and more students.

Remember, the Fund itself is not consumed - only the income from it. Whatever is in the "restricted trust fund" keeps working year after year, indefinitely into the future. The larger it grows, the more good it can do - not only once, but time after time as the years go by. After the 2010-11 educational grants were paid out, 566 students have received financial educational assistance because of your generosity. At that time, the total dollar amount of grants paid out since the program inception in 1964 totaled \$1,540.6500.00.

The OP for Competitive Exhibits is very much out of date. This is a meatball surgical change to the entire Rules and Award Committee OP.
