### **Believe it or Not!**

Following is a clip taken from an article on the internet. If you desire to read the entire article - go to Google - type in Trump's views on sage grouse. Interior Secretary Ryan Zinke ordered a review of current sage grouse management plans in June, saying he wanted to see improvement in the bird's conservation while also taking into account the local economic growth and job creation. And after 42 Years, Yellowstone Grizzly Will Be Taken Off the Endangered **Species List** 

The review task force came back with a list of recommendations that could relax rules related to the sage grouse around mineral leasing areas and allow for more flexibility in grazing management. Noting President Trump's executive order "Promoting Energy Independence and Economic Growth," the task force's review says: "A cooperative DOI and state effort can provide the flexibility for responsible economic growth and at the same time ensure conservation of [greater sage grouse] habitat." Zinke has ordered his agencies to begin implementing the recommendations immediately.

To keep the Federation membership informed as plans for the show develop and solidify, monthly updates will be published that showcase show themes, special events, and featured displays.

This issue of the Federation newsletter showcases silversmithing and jewelry arts offerings. Artists and teachers, Chris and Peggy Blickfeldt, have agreed to offer a class on introductory silversmithing techniques. You may recognize them from their association with the lapidary arts classes that are offered each fall at the Hancock Field Station in Oregon. For this two day class participants will design and make a silver pendant using sterling sheet and wire silver. Introductory techniques for cutting and soldering will be emphasized. All materials and tools needed to complete a pendant will be provided. Pre-registration is required and the class is limited to the first 10 people who sign up. If you have ever had an interest in dabbling in jewelry art this offering is right up your alley.

Another event will feature a competition involving students from area high schools which have jewelry art programs. The competition will have three categories: wire wrapping, fabrication with no soldering, and fabrication with soldering. This event will take place on Saturday April 28. Come and watch as the students utilize the skills they have learned.

A third event we are working on is an opportunity for show participants to learn how to make their own cabochon. Stay tuned for updates as this event takes shape.

### **NFMS Convention History:**

### February 5, 1938:

First formal meeting in Olympia Washington. Officers elected. Attendance of 500.

### October 16th, 1938:

Hosted by Oregon Agate & Mineral Society @ Multnomah Hotel in Portland, Oregon. The business meeting was presided by Dr. Dake and 150 enjoyed the banquet. There were 18 commercial & 48 private exhibits. On Sunday, it was opened to the public with the attendance of 3000: "the largest gathering of its kind ever held in America".

### October 14th & 15th, 1939:

Hosted by Gem Collectors Club of Seattle, Washington. Delegates represented 20 member organizations. Officers included: President Ray C. Gruhlke from Olympia, Washington, Vice-president Charles Flory, Secretary Mrs. Alma Fenton, & Treasurer, Rev. Byron W. Travis.

### October 12th & 13th, 1940:

Hosted by Columbian Geological Society @ Davenport Hotel in Spokane, Washington. Delegates represented 25 clubs. The banquet price was \$1.50 with only 350 tickets available! Officers at this convention were President Milton F. Reed from Seattle, Washington, Vice-president Phil Brogan, Secretary Mrs. Lloyd Roberson, & Treasurer Charles O. Fernquist. The first Directory was issued in 1940 printed by Don Major who donated his work as a printer & who managed to get enough ads to pay for the paper & ink.

### August 30th & 31st, 1941:

Hosted by Oregon Agate and Mineral Society in Portland, Oregon. Walter Sutter fluorescent exhibit continued to be highlight of shows and required a 5 ton truck to transport it from Tacoma to Portland! It included a "Pirates Treasure Chest" of fluorescent gems. The Bob Ross cabochon exhibit from Seattle was "again a feature in its Class". Officers presiding were President J. Lewis Renton of Portland, Oregon, Vice-president Don Major, Secretary A.W. Hancock, & Treasurer Dale Lambert.

### 1942.

Scheduled for Boise, Idaho. Cancelled d/t outbreak of war and travel restrictions.

1946, August 31-Sept 1: Hosted jointly by Idaho Gem Club, Owyhee Gem & Mineral Society, & the Snake River Gem Club with 23 clubs represented. Officers who presided during 5 year interval were President Don Major of Tenino, Washington, Vice-president E.E.Walden, Secretary M.F. Sandoz, & Treasurer Dale Lambert.

### 1947. August 30-31:

Hosted by Gem Collectors' Club in Seattle, Washington with 50 delegates attending the business meeting. Convention site was changed from Masonic Temple to the Civic Auditorium in order to accommodate all those requesting space for exhibition. Membership now 1501 with increased dues from 10 to20 cents! Officers presiding were President E.E. Walden (Boise, Idaho), Vice-president Lloyd Roberson, Secretary Mrs. J. Frank Murbach, and Treasurer Dale Lambert.

This year the AFMS, American Federation of Mineralogical Societies, was formed in Salt Lake City, Utah with Lloyd Roberson & Earl Van Deventer representing the Northwest Federation.

### 1948, Labor Day Weekend:

Hosted by the Montana Society of Natural & Earth Sciences in Bozeman, Montana. There were 34 clubs represented A standard membership card was established and a mat of the Northwest insignia was given to each club. Officers president Llyod Roberson (Seattle, Washington), Vice-president Harvey Murdock, Secretary Mrs. J. Frank Murbach, & Treasurer Paul Brannan.


### 1949

Hosted by the Eugene Mineral Club in Eugen, Oregon at the University of Oregon campus. The first regular Newsletter was issued this year mimeographed with 2-3 pages. No directory was issued this year as it is being printed only every other year. Officers presiding were President Harvey Murdock (Bozeman, Montana), Vice-president Harry M. Rhorer Jr., Secretary Mrs. Richard Rice, & Treasurer Paul Brannan.

Early conventions were the catalyst for the formation of many societies throughout the Pacific Northwest & even the country. Several hobby publication like "The Mineralogist" by the Northwest's own Dr. H. C. Dake with & comments were responsible for the rapid growth.

The American Federation of Mineralogical Societies held its first meeting on June 12, 1947 in Salt Lake City, Utah. The effort was spearheaded by Dr. Richard Pearl, author of numerous hobby books who represented the Rocky Mountain Federation, Dr. Ben Hur Wilson of the Midwest Federation, & Dr. H.C. Dake of the Northwest Federation. The First Annual Meeting of the American Federation resulted from this organizational meeting was held in Colorado in June of 1948.

# HIGHLIGHTS OF 2017 AFMS ANNUAL MEETING by Evan Day

### **UNIFORM RULES Committee:**

The first event of this year's national convention of the American Federation of Mineralogical Societies in Ventura, CA. was a meeting of the AFMS Uniform Rules Committee on Wednesday, June 7. As chairman of the Northwest Federation's Rules and Awards committee, I attended as the NFMS's delegate. Different than most such meetings there were no controversial resolutions from the Regional Federations, and we only discussed minor editorial corrections in the Meteorite Class, a new category adopted at Albany, OR in 2016.

### **ANNUAL MEETING:**

The morning of Thursday, June 8, saw much the same scenario at the AFMS Annual Meeting. In attendance were the AFMS Officers, all seven Regional Presidents and Vice Presidents. NFMS Prsident Jim Bosley and First VP Keith Fackrell represented us. The only thing of note brought up was a brief discussion of Sage Grouse regulations status, and of course the folks from back East and California had no clue on this issue which severely impacts rockhounding in the Northwest.

### **AFMS SHOW:**

This year's show on Friday-Sunday was hosted by the California Federation and the Ventura Gem & Mineral Society in two huge buildings of the Ventura County Fairgrounds, right on the ocean beach. All 40 dealers were housed in one, and the second had all the exhibits, juniors, demonstrations, etc. with food trucks in the plaza between. They provided many excellent talks and lectures; ranging from local geology to our old friend Bob Jones (Editor of Rock & Gem) fun talk on his world travels over 80 years of rock-

### **EXHIBITS**

About 1/3 of the main building was devoted to exhibits, about 200 in all, including 77 competitive entries from across the country. This required 95 judging sessions since new Master entries from the CFMS which got 90 points in Regional judging automatically were re-judged by the AFMS three -person teams. It was a very full Friday of work for about 20 judges from across the country. I personally judged about 15 cases of Meteorites, Jewelry, Minerals, and Fossils. The Meteorites were especially fun since I was involved in preparing and adopting the new rules in 2016, and now I was eyeball-to-eyeball judging for the first time ever with two real exhibits. The Host club twisted arms to get their members to compete, and got great response, but several wound up in the wrong category (the committee corrected many errors before judging). We usually evaluated cases Disqualified for identifying the exhibitor in the case, etc. as though they were valid entries, to help the exhibitors try again next year. As expected at a national show, the Non-Competetitive exhibits were very good, I spent most of Saturday afternoon with them.


### **BANQUET:**


